Street, San Diego, California in Department 3 on March 1, 2023, at 10:00 a.m. (Pacific Standard Time). Unless otherwise authorized by the Court, the Parties will appear in person. As stated at the Status Conference, Inland Empire Health Plan is authorized to appear at the Sale Hearing via Zoom.

3. Except as modified herein, the Bidding Procedures Order remains in full force and effect.

4. The Court shall retain exclusive jurisdiction over all matters arising from or related to the interpretation and implementation of this Order.
