**MOTION OF THE REORGANIZED DEBTOR FOR AN ORDER FURTHER
EXTENDING THE DEADLINE FOR THE REORGANIZED DEBTOR TO OBJECT TO
CLAIMS AND OLD GP/LP EQUITY INTERESTS
AND GRANTING RELATED RELIEF**

The reorganized debtor in the above-captioned case (the “**Reorganized Debtor**”),² by and through its undersigned counsel, respectfully represents as follows:

JURISDICTION

1. This Court has jurisdiction to consider this motion (the “**Motion**”) under 28 U.S.C. §§ 157 and 1334 and the *Amended Standing Order of Reference* from the United States District Court for the District of Delaware dated as of February 29, 2012. This is a core proceeding under 28 U.S.C. § 157(b)(2). Venue of the Chapter 11 Case and this Motion in this district is proper under 28 U.S.C. §§ 1408 and 1409.

BACKGROUND

2. On July 15, 2019 (the “**Petition Date**”), the Debtors filed voluntary petitions in this Court commencing the Chapter 11 Case.

3. On December 18, 2019, the Court entered an order [Docket No. 721] (the “**Confirmation Order**”) confirming the *Modified Second Amended Joint Plan of Reorganization for Emerge Energy Services LP and its Affiliate Debtors Under Chapter 11 of the Bankruptcy Code*, which was attached to the Confirmation Order as Exhibit 1 thereto (the “**Plan**”).³ The Plan became effective, and was substantially consummated, on December 20, 2019 (the “**Effective Date**”). See Docket No. 733.

CLAIMS OBJECTION DEADLINE

4. Pursuant to the Plan, the initial deadline to object to prepetition claims (the “**Claims**”) was “the latest of (a) one hundred eighty (180) days after the Effective Date; (b) ninety (90) days after the Filing of an applicable Proof of Claim, or (c) such other date as may be specifically fixed by Final Order of the Bankruptcy Court for objecting to such Claim.” See Plan Article I.C. (definition of “Claims Objection Deadline”).⁴ Accordingly, the initial deadline to file objections to Claims (the “**Claims Objection Deadline**”) was Wednesday, June 17, 2020.

5. Additionally, pursuant to the Plan, the initial deadline to object to Old GP/LP Equity Interests was “the later of (a) one hundred eighty (180) days after the Effective Date or (b) such other date as may be fixed by Final Order of the Bankruptcy Court for objecting to such Old GP/LP Equity Interest.” See Plan Article I.C. (definition of “Old GP/LP Objection Deadline”). Accordingly, the initial deadline to file objections to Old GP/LP Equity Interests (the “**Old GP/LP Objection Deadline**”) was Wednesday, June 17, 2020.

⁴ The Plan also separately sets a deadline to object to Administrative Claims, which is “the later of (a) 120 days after the Effective Date and (b) 60 days after the Filing of the applicable request for payment of Administrative Claims, if applicable, as the same may be modified or extended from time to time by Final Order of the Bankruptcy Court.” See Confirmation Order ¶ 27; see also Plan Article II.A.1. The Reorganized Debtor separately filed a motion seeking an extension of the Administrative Claims Objection Deadline, and the Court has entered an order [Docket No. 1029] granting such relief.

6. On June 30, 2020, the Court entered an order [Docket No. 862] extending the initial Claims Objection Deadline and the initial Old GP/LP Objection Deadline (the “**First Claims and Old GP/LP Objection Deadline Extension**”) to October 15, 2020.

7. On October 29, 2020, the Court entered an order [Docket No. 924] extending the First Claims and Old GP/LP Objection Deadline Extension (the “**Second Claims and Old GP/LP Objection Deadline Extension**”) to February 12, 2021.

8. On February 16, 2021, the Court entered an order [Docket No. 976] extending the Second Claims and Old GP/LP Objection Deadline Extension (the “**Third Claims and Old GP/LP Objection Deadline Extension**”) to June 14, 2021.

9. On June 21, 2021, the Court entered an order [Docket No. 1009] extending the Third Claims and Old GP/LP Objection Deadline Extension (the “**Fourth Claims and Old GP/LP Objection Deadline Extension**”) to October 12, 2021.

RELIEF REQUESTED

10. By this Motion, the Reorganized Debtor seeks entry of an order, substantially in the form attached hereto as Exhibit A (the “**Proposed Order**”), extending the Fourth Claims and Old GP/LP Objection Deadline Extension by approximately 120 days, from October 12, 2021,⁵ through and including February 9, 2022, without prejudice to the ability of the Reorganized Debtor to request further extensions.

BASIS FOR RELIEF

11. Section 105(a) of the Bankruptcy Code empowers the Court to “issue any order, process, or judgment that is necessary or appropriate to carry out the provisions of this

title.” 11 U.S.C. § 105. *See, e.g., Adelphia Bus. Solutions, Inc. v. Abnos*, 482 F.3d 602, 609 (2d Cir. 2007) (“Section 105(a) grants broad equitable power to the bankruptcy courts to carry out the provisions of the Bankruptcy Code so long as that power is exercised within the confines of the Bankruptcy Code”). Further, the Plan allows both the Claims Objection Deadline and the Old GP/LP Objection Deadline to be extended to “such other date as may be specifically fixed by Final Order of the Bankruptcy Court.” *See* Plan Article I.C. (definition of “Claims Objection Deadline”); *see also* Plan Article I.C. (definition of “Old GP/LP Objection Deadline”). Accordingly, this Court has authority to extend such deadlines.

12. The Reorganized Debtor respectfully submits that the proposed extension of the Fourth Extended Claims and Old GP/LP Objection Deadlines is appropriate and reasonable under the circumstances.

13. Initially, since the Effective Date, the Reorganized Debtor has been reviewing and assessing the Claims and interests filed or asserted in the Chapter 11 Case. Although the Reorganized Debtor has made, and continues to make, progress in the claims reconciliation process, the requested extension is necessary to avoid the Reorganized Debtor having to file objections which could have been avoided if they were given additional time to review, analyze and consensually resolve any potentially disputed Claims and/or interests. Indeed, the Reorganized Debtor submits that it would be a waste of resources to prematurely file objections to Claims and interests at this stage. Accordingly, for that reason alone, the Motion should be granted.

14. Further, due to various “shelter-in-place” laws and “work-from-home” mandates resulting from the national and international emergency caused by the novel coronavirus, the Reorganized Debtor’s efforts to resolve and review all Claims and interests, has

been significantly slowed. These laws and mandates, while justifiable under the circumstances, made access to the Debtor's books and records difficult and placed significant hardship on the personnel necessary for the Reorganized Debtor to perform the required analysis of the Claims. As a result, for more than a year, the Reorganized Debtor had difficulty reviewing and reconciling Claims. These facts further support the requested extension of the Fourth Claims and Old GP/LP Objection Deadline Extension.

15. Accordingly, the requested extension of 120 days is reasonable and will provide additional time for the Reorganized Debtor to pursue consensual resolutions of any disputed Claims and interests and/or file objections where such resolutions cannot be reached.

CONSENT TO JURISDICTION

16. Pursuant to Local Rule 9013-1(f), the Reorganized Debtor consents to the entry of a final judgment or order with respect to the Motion if it is determined that the Court would lack Article III jurisdiction to enter such final order or judgment absent consent of the parties.

NOTICE

17. Notice of this Motion shall be provided to (a) the U.S. Trustee; and (b) any other party entitled to notice pursuant to Bankruptcy Rule 2002 or order of the Court. The Reorganized Debtor submits that, under the circumstances, no other or further notice is required.

NO PRIOR REQUEST

19. No prior request for the relief sought herein has been made to this Court or any other court.

WHEREFORE, the Reorganized Debtor respectfully requests that the Court enter the Proposed Order, substantially in the form attached hereto as Exhibit A, granting the relief requested herein and such other and further relief as may be just and proper.

**ORDER FURTHER EXTENDING THE DEADLINE FOR THE REORGANIZED
DEBTOR TO OBJECT TO CLAIMS AND OLD GP/LP EQUITY INTERESTS**

Upon the motion (the “**Motion**”)² of the Reorganized Debtor for entry of an Order further extending the time by which the Reorganized Debtor may object to Claims and interests; and the Court having reviewed the Motion and having considered the statements of counsel with respect to the Motion at a hearing (if any) before the Court; and the Court having jurisdiction to consider the Motion and the relief requested therein in accordance with 28 U.S.C. §§ 157 and 1334 and the *Amended Standing Order of Reference from the United States District Court for the District of Delaware*, dated as of February 29, 2012; and the Court having found that this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2) and that this Court may enter a final order consistent with Article III of the United States Constitution; and the Court having found that venue of this proceeding and the Motion in this district is proper pursuant to 28 U.S.C. §§ 1408 and 1409; and it appearing that proper and adequate notice of the Motion has been given and that no other or further notice is necessary; and upon the record herein; and after due deliberation

thereon; and the Court having determined that there is good and sufficient cause for the relief granted in this order, it is hereby

ORDERED, ADJUDGED, AND DECREED THAT:

1. The Motion is GRANTED as set forth herein.
2. Each of the Claims Objection Deadline and the Old GP/LP Objection Deadline is hereby extended through and including February 9, 2022.
3. This Order is without prejudice to the Reorganized Debtor's right to request additional extensions of the Claims Objection Deadline or the Old GP/LP Objection Deadline.
4. The Court shall retain exclusive jurisdiction over any and all matters arising from or related to the implementation or interpretation of this Order.
