STIPULATION RELATED TO CANCELLATION OF COLORADO SURETY BONDS

The above debtors and debtors in possession (the "<u>Debtors</u>") in these chapter 11 cases (the "<u>Chapter 11 Cases</u>") and Liberty Mutual Insurance Company ("<u>Liberty Mutual</u>") hereby stipulate and agree as follows:

RECITALS

- 1. The Debtors commenced the Chapter 11 Cases on June 30, 2022 (the "Petition Date").
- 2. Certain of the Debtors' former employees are holders of mortgage loan originator licenses in the State of Colorado (the "<u>Licenses</u>"). As required under Colorado law, the Debtors provided, on the employees' behalf (as holders of the Licenses), surety bonds to the State of Colorado Division of Real Estate for any claims made against the employee under the Colorado Mortgage Loan Originator Licensing Act.
- 3. Prior to the Petition Date, Liberty Mutual issued the surety bonds listed on **Exhibit A** hereto (the "CO Surety Bonds") on behalf of the Debtors' Colorado employees who held the

4. The Debtors no longer employ the individuals identified on the individual CO

Surety Bonds. As a result, the Debtors no longer need the CO Surety Bonds and Liberty Mutual

and the Debtors desire to cancel the CO Surety Bonds. The Debtors and Liberty Mutual have

entered into this Stipulation to effectuate the cancellation of the CO Surety Bonds.

NOW THEREFOR, FOR GOOD AND VALUABLE CONSIDERATION, THE

ADEQUACY AND RECEIPT OF WHICH IS HEREBY ACKNOWLEDGED, THE PARTIES

HERETO STIPULATE AND AGREE AS FOLLOWS:

1. This Stipulation shall become effective on the date an order approving this

Stipulation is entered on the docket of the Debtors' Chapter 11 Cases (the "Effective Date"). On

the Effective Date, the automatic stay imposed by 11 U.S.C. § 362, shall be modified to permit

Liberty Mutual to issue notices of cancellation of the CO Surety Bonds and take any steps

necessary to complete the cancellation of the CO Surety Bonds.

2. This Stipulation is limited to the cancellation of the CO Surety Bonds identified on

Exhibit A. All other surety bonds issued by Liberty Mutual on behalf of the Debtors or the

Debtors' employees shall remain in place unless and until modified, terminated or cancelled by

agreement of the parties or order of the Bankruptcy Court.
