I am over the age of 18 and not a party to this action. Except as otherwise noted, I could and would testify to the following based upon my personal knowledge.

2. On September 9, 2021, the Court entered the *Order Appointing Kurtzman Carson Consultants LLC as Claims and Noticing Agent for the Debtor Pursuant to 28 U.S.C § 156 (c), 11 U.S.C. § 105(a) and S.D.N.Y.LBR 5075-1 Nunc Pro Tunc to the Petition Date* [Docket No. 46].

3. On October 26, 2021, the Court entered the *Order Authorizing the Debtors to Retain and Employ Kurtzman Carson Consultants LLC as Administrative Advisor Effective Nunc Pro Tunc to the Petition Date* [Docket No. 217].

4. Consistent with its retention as claims, noticing, and administrative agent, KCC is charged with, among other things, printing and distributing Solicitation Packages to creditors and other interested parties pursuant to the to the instructions set forth in the *Debtor’s Motion for Entry of an Order (A) Approving the Disclosure Statement; (B) Approving Solicitation and Voting Procedures; (C) Approving Forms of Ballots; (D) Scheduling a Confirmation Hearing; and (E) Establishing Notice and Objection Procedures* [Docket No. 197] (the “Disclosure Statement Motion”). The Court entered an *Order (A) Approving the Disclosure Statement; (B) Approving Solicitation and Voting Procedures; (C) Approving Forms of Ballots; (D) Scheduling Confirmation Hearing; and (E) Establishing Notice and Objection Procedures* [Docket No. 259] (the “Disclosure Statement Order”) on November 12, 2021.
