I, Danielle Gillis, affiant, state the following based upon my personal knowledge:


1. I am a competent person over eighteen years of age and not a party to this action.

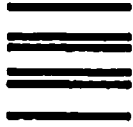
