The ResCap Liquidating Trust, as successor in interest to GMAC Mortgage, LLC, a defendant in this adversary proceeding, and plaintiff Shelley von Brincken, hereby submit this Joint Progress Report pursuant to the Mandatory Supplemental AP Procedures for AP Actions (“Supplemental AP Procedures”) entered by the Bankruptcy Court in the above-captioned chapter 11 cases on March 22, 2013 [Docket No. 3293], as amended on April 22, 2013, [Docket No.





3490], and the Notice of Applicability of The Order Approving Mandatory Supplemental AP Procedures filed in connection with this Adversary Proceeding on August 30, 2013 [Docket No. 4].

On October 4, 2013, Plaintiff, counsel to GMAC Mortgage, LLC, and Silverman Acampora LLP, as special counsel to the Official Committee of Unsecured Creditors for borrower matters held the Initial Conference in this Adversary Proceeding. The parties continued to engage in settlement talks after that date, but have not reached a consensual resolution of the issues in this adversary proceeding.

On February 21, 2014, Plaintiff filed an amended complaint. Pursuant to the Supplemental AP Procedures, the Defendants' deadline to respond to Plaintiffs' amended complaint is May 26, 2014 (30 days after the April 24, 2014 pre-trial conference). The ResCap Liquidating Trust plans to file a motion to dismiss the amended complaint on behalf of GMAC Mortgage, LLC on or before that date.


