Wilson ("Wilson"), moves this Court for an Order 8 9 directing the Clerk of the Court file Plaintiff's REPLY IN OPPOSITION TO 10 RESCAP LIQUIDATING TRUST'S SUPPLEMENTAL BRIEF IN SUPPORT 11 OF DEBTOR'S MOTION FOR DISMISSAL OF ADVERSARY PROCEEDING PURSUANT TO BANKRUPTCY RULE 7012(B) AND FRCP 12(B)(1) AND 12 12(B)(6) OR, IN THE ALTERNATIVE, PERMISSIVE ABSTENSTION 13 14 PURSUANT TO 28 U.S.C. § 1334(c)(1); and OBJECTION TO DECLARATION 15 OF LAUREN GRAHAM DELEHEY, CHIEF LITIGATION COUNSEL FOR 16 THE RESCAPLIQUIDATING TRUST, IN SUPPORT OF DEBTORS' MOTION 17 FOR DISMISSAL OF ADVERSARY PROCEEDING PURSUANT TO 18 BANKRUPTCY RULE 7012(B) AND FRCP 12(B)(1) AND 12(B)(6) OR, IN 19 THE ALTERNATIVE, PERMISSIVE ABSTENSTION PURSUANT TO 28 20 U.S.C. § 1334(c)(1) (hereinafter "The Replies") nunc pro tunc June 19, 2014 at 1:44 p.m. 21 22 STATEMENT OF FACTS 23 At the May 1, 2014 hearing the Court Ordered Debtor to submit a 24 Supplemental Brief and Declaration to Debtor's Motion For Dismissal of Adversary Proceeding Pursuant To Bankruptcy Rule 7012(B) and FRCP 12(B)(1) 25 26 AND 12(B)(6) or, In The Alternative, Permissive Abstention Pursuant To 28

U.S.C. § 1334(c)(1). Additionally, Plaintiff was given 1 week to reply to Debtor's 1 2 Supplemental Brief. 3 By stipulation the Debtor and Plaintiff ("the parties") agreed to extend the deadline for the filing of The Replies to June 19, 2014 at 5:00 p.m. (See Dkt. # 57). 4 5 On June 18, 2014, Wilson deposited, postage prepaid, Express Delivery 6 guaranteed, with the United States Postal Service ("USPS") The Replies, see USPS 7 Receipt attached hereto and incorporated herein as "Exhibit A." On June 23, 2014, Wilson observing The Replies were not docketed called 8 9 the Clerk of the Court to inquire the reasoning thereof. The Clerk of the Court, Ms. Aurea Suarez, informed Ms. Wilson The Replies were not received until June 20, 10 2014, and told Ms. Wilson if she had evidence of the delivery on June 19th that she. 11 12 Ms. Suarez, would see what she could do regarding the filing date and time. 13 Wilson accessed the United States Postal Service website to secure the "Proof of Delivery." (See "Exhibit B" attached hereto and incorporated herein by 14 15 reference) The Proof of Delivery states The Replies were delivered on June 19, 16 2014 at 1:44 p.m. Wilson emailed Ms. Suarez the USPS Receipt and the Proof of Delivery 17 following up with a phone call to Ms. Suarez. Ms. Suarez stated there is no way the 18 19 USPS could deliver The Replies from their N.Y office to the Court in five minutes 20 therefore she could do nothing for Ms. Wilson. Ms. Suarez's response compels 21 Wilson to file this Motion. 22 **ARGUMENT** 23 By stipulation of the parties Wilson had until June 19, 2014 at 5:00 p.m. EDT to file The Replies. 24

Local Bankruptcy Rule 1002-1 states, "A petition commencing a case under the Bankruptcy Code may be filed in any office of the Clerk or by electronic means established by the Court.

Local Bankruptcy Rule 5005-2 in relevant part states, "Unless the Court directs otherwise, all attorneys practicing in the Court, including attorneys admitted pro hac vice, are required to file all pleadings, motions, or other documents (except documents to be placed under seal) by electronic means, and all such documents required to be signed or verified shall be signed or verified by electronic means, in each case consistent with the Procedures for the Filing, Signing, and Verification of Documents by Electronic Means issued by the Court, which shall be available on the Court's website (http://www.nysb.uscourts.gov/sites/default/files/5005-2-procedures.pdf)."

Local Bankruptcy Rule 1073-1(a) in relevant part states, "Cases. Where the street address of the debtor set forth on the petition is in (i) New York County or Bronx County, the Clerk shall assign the case to a Judge sitting in New York County; (ii) Rockland County or Westchester County, the Clerk shall assign the case to a Judge sitting in Westchester County; or (iii) Dutchess County, Orange County, Putnam County, Sullivan County or Ulster County, the Clerk shall assign the case to a Judge sitting in Dutchess County. No case assignment will be based upon a post office box address."

In re Gubelman, 10 F. 7 8 926, 929 (2d Cir. 1925); cited in Greenwood v. New York, 842 F.2d 636, 639 (2d 9 Cir. 1988). 10 Wilson asserts the evidence clearly shows The Replies were properly addressed and delivered to the custody of the Clerk of the Court for Southern 11 12 District Manhattan on the due date of June 19, 2014 at 1:44 p.m. 13 RELIEF REQUESTED WHEREFORE Plaintiff, Jennifer L.
