FINAL ORDER (I) AUTHORIZING THE DEBTORS TO CONTINUE THEIR SHARED SERVICES AND (II) GRANTING RELATED RELIEF

Upon the motion (the "Motion")² of TECT Aerospace Group Holdings, Inc. and its debtor affiliates in the above-captioned chapter 11 cases, as debtors and debtors in possession (collectively, the "Debtors"), for entry of a final order (this "Final Order") (i) authorizing the Debtors to continue performing under the Shared Services Agreements post-petition in the ordinary course of business and (ii) granting related relief, all as more fully set forth in the Motion; and the Court having jurisdiction to consider the Motion and the relief requested therein pursuant to 28 U.S.C. §§ 157(a)–(b) and 1334(b), and the *Amended Standing Order of Reference* from the United States District Court for the District of Delaware, dated February 29, 2012; and consideration of the Motion and the requested relief being a core proceeding pursuant to 28 U.S.C. § 157(b); and venue being proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409; and due and proper notice of the Motion having been provided to the Notice Parties under the circumstances, and it appearing that no other or further notice need be provided; and this Court

having held a hearing, if necessary, to consider the final relief requested in the Motion (the "Hearing"); and upon the First Day Declaration; and the Court having determined that the legal and factual bases set forth in the Motion and at the Hearing, if any, establish just cause for the relief granted herein; and it appearing that the relief requested in the Motion is in the best interests of the Debtors, their estates, creditors, and all parties in interest; and upon all of the proceedings had before the Court and after due deliberation and sufficient cause appearing therefor,

IT IS HEREBY ORDERED THAT:

- 1. The Motion is granted on a final basis to the extent set forth herein.
- 2. The Debtors are authorized, but not directed, to continue performing under the Shared Services Agreements post-petition in the ordinary course of business, provided, however, the Debtors shall not pay any amounts owing prepetition under the Shared Services Agreements.
- 3. Notwithstanding entry of this Final Order, nothing herein shall create, nor is intended to create, any rights in favor of or enhance the status of any claims held by, any party.
- 4. Nothing herein shall be deemed to provide a waiver of any chapter 5 cause of action or other state claims that may have arisen pursuant to the Shared Services Agreements or performance thereunder.
- 5. The Official Committee of Unsecured Creditors shall have the rights set forth in the Final Order approving the Motion of Debtors for Entry of Interim and Final Order (I) Authorizing Debtors to (A) Continue Existing Cash Management System, Bank Accounts, and Business Forms, (B) Make Ordinary Course Changes Thereto, (C) Honor Certain Prepetition Obligations Related to the Use Thereof, and (D) Continue Certain Intercompany Transactions; (II) Grant Administrative Expense Priority for Post-Petition Debtor Intercompany Claims; (III) Extending the Time to Comply with 11 U.S.C. §345(b); and (IV) Granting Related Relief [Docket

No. 3] to review and/or approve the Intercompany Transactions that arise via the Shared Services Agreements.

- 6. Each of the Banks at which the Debtors maintain their accounts relating to the payment of obligations on account of the Shared Services Agreements are authorized to (i) receive, process, honor, and pay all checks presented for payment and to honor all fund transfer requests made by the Debtors related thereto, to the extent that sufficient funds are on deposit in those accounts and (ii) accept and rely on all representations made by the Debtors with respect to which checks, drafts, wires, or automated clearing house transfers should be honored or dishonored in accordance with this or any other order of the Court, whether such checks, drafts, wires, or transfers are dated prior to, on, or subsequent to the Petition Date, without any duty to inquire otherwise.
- 7. Nothing contained in this Final Order shall constitute a finding that the services provided under the Shared Services Agreements, either prepetition or postpetition, constitute reasonably equivalent value for payments and/or transfers made pursuant to the Shared Services Agreements.
- 8. Nothing contained in this Final Order shall prevent the Committee from seeking to disgorge any payments made pursuant to the Shared Services Agreements.
- 9. Nothing contained in the Motion, the Interim Order, or this Final Order, nor any payment made pursuant to the authority granted by the Interim Order or this Final Order, is intended to be or shall be construed as (i) an admission as to the validity of any claim against the Debtors, (ii) a waiver of the Debtors' or any appropriate party in interest's rights to dispute the amount of, basis for, or validity of any claim against the Debtors, (iii) a waiver of any claims or causes of action which may exist against any creditor or interest holder, or (iv) an approval,

assumption, adoption, or rejection of any agreement, contract, lease, program, or policy between

the Debtors and any third party under section 365 of the Bankruptcy Code.

10. Under the circumstances of these chapter 11 cases, notice of the Motion is adequate

under Bankruptcy Rule 6004(a) and the Local Rules.

11. Notwithstanding Bankruptcy Rule 6004(h), this Final Order shall be immediately

effective and enforceable upon its entry.

12. The Debtors are authorized to take all action necessary to effectuate the relief

granted in this Final Order.

13. The Court shall retain jurisdiction to hear and determine all matters arising from or

related to the implementation, interpretation, and/or enforcement of this Final Order.
