DECLARATION OF SYDNEY REITZEL WITH RESPECT TO THE TABULATION OF VOTES ON THE JOINT CHAPTER 11 PLAN OF LIQUIDATION FOR TECT AEROSPACE GROUP HOLDINGS, INC. AND ITS AFFILIATED DEBTORS

I, Sydney Reitzel, depose and say under the penalty of perjury:

- 1. I am a Senior Consultant of Corporate Restructuring Services employed by Kurtzman Carson Consultants LLC ("**KCC**"), whose main business address is 222 N. Pacific Coast Highway, 3rd Floor, El Segundo, California 90245.
- 2. I submit this declaration (the "**Declaration**") regarding the solicitation and tabulation of Ballots cast on the *Joint Chapter 11 Plan of Liquidation for TECT Aerospace Group Holdings, Inc. and its Affiliated Debtors* [D.I. 737] (as may have been revised, supplemented, modified and/or amended from time to time, the "**Plan**").^{2, 3} Except as otherwise noted, all facts set forth herein are based on my personal knowledge, knowledge that I acquired from individuals

under my supervision, and my review of relevant documents. I am authorized to submit this Declaration on behalf of KCC. If I were called to testify, I could and would testify competently as to the facts set forth herein.

- 3. The Bankruptcy Court authorized KCC's retention (i) as claims and noticing agent to the Debtors on April 7, 2021 pursuant to the *Order Authorizing the Appointment of Kurtzman Carson Consultants LLC as Claims and Noticing Agent* Nunc Pro Tunc to the Petition Date [D.I 29], and (ii) as administrative advisor to the Debtors on May 5, 2021 pursuant to the *Order Authorizing the Debtors to Retain and Employ Kurtzman Carson Consultants LLC as Administrative Advisor Effective* Nunc Pro Tunc to the Petition Date [D.I. 132] (together, the "Retention Orders"). The Retention Orders authorize KCC to assist the Debtors with, among other things, the service of solicitation materials and tabulation of votes cast to accept or reject the Plan. KCC and its employees have considerable experience in soliciting and tabulating votes to accept or reject chapter 11 plans.
- 4. On January 25, 2022, the Bankruptcy Court entered the *Order (I) Approving Disclosure Statement and Form and Manner of Notice of Disclosure Statement Hearing, (II) Establishing Solicitation, Voting and Related Procedures, (III) Scheduling Confirmation Hearing (IV) Establishing Notice and Objection Procedures for Confirmation of Plan, and (V) Granting Related Relief* [D.I. 735] (the "**Disclosure Statement Order**"), establishing, among other things, the Solicitation, Voting, and Tabulation Procedures. KCC adhered to the procedures outlined in the Disclosure Statement Order and the Ballots distributed to parties entitled to vote on the Plan. I supervised the solicitation and tabulation performed by KCC's employees.

A. Service and Transmittal of Solicitation Packages and Related Information

- 5. Pursuant to the Disclosure Statement Order, on February 8, 2022, KCC caused the Solicitation Packages to be served on all known Holders of Claims in Classes 3, 4, and 5 (together, the "Voting Classes"). In lieu of a Solicitation Package, all known (i) Holders of Claims in Classes 1 and 2 received the Confirmation Hearing Notice and Notice of Non-Voting Status (the "Unimpaired Non-Voting Package"), and (ii) Holders of Claims in Class 6 and Holders of Interests in Class 7 (Holders of Claims and Interests in Classes 1, 2, 6, and 7, together, the "Non-Voting Classes") received the Confirmation Hearing Notice, the Disclosure Statement, and the Plan (the "Impaired Non-Voting Package"), all in accordance with the Disclosure Statement Order. Furthermore, KCC caused the Confirmation Hearing Notice to be served on the creditor matrix and all other parties required to receive such notice pursuant to the Disclosure Statement Order. A certificate of service evidencing the foregoing was filed with the Bankruptcy Court on February 16, 2022 at D.I. 771 (the "Certificate of Service").
- 6. On January 28, 2022, KCC posted links to the electronic versions of the Confirmation Hearing Notice, Plan, Disclosure Statement, and Disclosure Statement Order, on the public access website at www.kccllc.net/TECTAerospace.
- 7. KCC also forwarded Solicitation Packages and Confirmation Hearing Notices to voting and creditor matrix parties whose packages were returned with a forwarding address or if an alternate address was available. The supplemental certificate of service evidencing the foregoing was filed with the Bankruptcy Court at D.I. 789.

B. The Tabulation Process

8. The Disclosure Statement Order established January 25, 2022 as the Voting Record Date to determine which Holders of Claims and Interests were entitled to receive the Solicitation

Package, Unimpaired Non-Voting Package, or Impaired Non-Voting Package, as applicable. Pursuant to the Disclosure Statement Order, Holders of Claims in Class 3 (Prepetition Credit Agreement Claims and DIP Claims), Class 4 (General Unsecured Claims), and Class 5 (Non-Released Party General Unsecured Claims) were entitled to vote to accept or reject the Plan. No other classes were entitled to vote on the Plan.

- 9. In accordance with the Solicitation Procedures, KCC worked closely with the Debtors' advisors to identify the Holders in the Voting Classes entitled to vote as of the Voting Record Date, and to coordinate the distribution of Solicitation Packages to such Holders. A detailed description of KCC's distribution of Solicitation Packages is set forth in the Certificate of Service.
- 10. In accordance with the Solicitation, Voting, and Tabulation Procedures, KCC received, reviewed, determined the validity of, and tabulated the Ballots submitted to vote on the Plan. Each Ballot submitted to KCC was date-stamped, scanned, assigned a Ballot number, entered into KCC's voting database, and processed. To be included in the tabulation results as valid, a Ballot must have been (a) properly completed pursuant to the Solicitation, Voting, and Tabulation Procedures, (b) executed by the relevant holder entitled to vote on the Plan (or such holder's representative), (c) returned to KCC via an approved method of delivery set forth in the Solicitation, Voting, and Tabulation Procedures unless the delivery method requirement was waived by the Debtors, and (d) received by KCC on or before the Voting Deadline (i.e., 4:00 p.m. (Eastern Time) on the February 25, 2022), which was established by the Disclosure Statement Order.

11. The final tabulation of votes cast by timely and properly completed Ballots received

by KCC is attached hereto as Exhibit A. The detailed Ballot report for the Class 3, 4, and 5

Ballots is attached hereto as Exhibit A-1, Exhibit A-2, and Exhibit A-3, respectively.

C. Ballots That Were Not Counted

12. A report of any parties in the Voting Classes excluded from the final tabulation, and

the reasons for exclusion of such Ballots, is attached hereto as Exhibit B. All such Ballots were

not counted for one of the following reasons: Ballot lacked an original signature, Ballot did not

indicate an acceptance or rejection of the Plan (i.e. an "abstained" vote), or the Ballot was returned

late.

Conclusion

To the best of my knowledge, information and belief, the foregoing information

concerning the distribution, submission, and tabulation of Ballots in connection with the Plan is

true.
