PLEASE TAKE NOTICE that, on March 29, 2021, the debtors and debtors in possession in the above-captioned chapter 11 cases (collectively, the "Debtors") filed the Debtors' Motion for Entry of: (A) an Order (I) Approving Bidding Procedures in Connection With the Sale of Substantially All of the Debtors' Assets, (II) Authorizing the Debtors to Enter Into the Stalking Horse Purchase Agreement, (III) Scheduling an Auction for and Hearing to Approve the Sale, (IV) Approving Notice of Respective Date, Time and Place for Auction and for Hearing on Approval of Sale, (V) Approving Procedures for the Assumption and Assignment of Certain Executory Contracts and Unexpired Leases, (VI) Approving Form and Manner of Notice Thereof, and (VII) Granting Related Relief; and (B) An Order Authorizing and Approving (I) the Sale Free and Clear of Liens, Claims, Rights, Encumbrances, and Other Interests, and (II) the Assumption and Assignment of Certain Executory Contracts and Unexpired Leases and (III) Related Relief [Docket No. 12] the "Bidding Procedures Motion"). On April 22, 2021, the United States Bankruptcy Court for the District of Delaware entered an order [Docket No. 87] (the "Bidding Procedures Order")² approving the Bidding Procedures Motion and scheduling an auction (the "Auction") and a hearing to approve the proposed sale or disposition of the Debtors' assets, and approving the form and manner of notices related thereto.

PLEASE TAKE FURTHER NOTICE that on May 19, 2021, the Debtors filed the *Notice of Adjournment of Auction* [Docket No. 142], adjourning the Auction to a date and time to be determined, and on May 25, 2012, the Debtors filed a notice [Docket No. 153] re-scheduling the Auction <u>solely with respect to the sale of certain spare parts and inventory identified as 453</u> <u>Saab 340B Plus and 4020 Bombardier 0400</u> (the "Specified Assets") to May 26, 2020 at 11:00 a.m. (ET) (the "Limited Auction").
