SUPPLEMENTAL CERTIFICATE OF SERVICE

I, Cerene Credo, depose and say:

1. I am employed by Kurtzman Carson Consultants LLC (“**KCC**”), the claims, noticing and administrative advisor for the Debtors in the above-captioned cases. I submit this supplemental certificate in connection with the service of solicitation materials (the “**Solicitation Packages**”) for the *Combined Disclosure Statement and Joint Chapter 11 Plan of AeroCentury Corp., and its Affiliated Debtors* [Docket No. 225] (the “**Combined Disclosure Statement and Plan**”). I am over the age of 18 and not a party to this action. Except as otherwise noted, I could and would testify to the following based upon my personal knowledge.

2. On March 31, 2021, the Court entered the *Order Authorizing the Debtors to Employ and Retain Kurtzman Carson Consultants LLC as Claims and Noticing Agent Effective as of the Petition Date* [Docket No. 31].

3. On April 30, 2021, the Court entered the *Order Authorizing the Debtors to Employ Kurtzman Carson Consultants LLC as Administrative Advisor as of the Petition Date* [Docket No. 115].

4. Consistent with its retention as claims, noticing and administrative advisor, KCC is charged with, among other things, the duty of printing and distributing Solicitation Packages to creditors and other interested parties pursuant to the instructions set forth in the *Debtors' Motion for Entry of an Order (I) Approving the Combined Disclosure Statement and Plan on an Interim Basis for Solicitation Purposes Only; (II) Establishing Solicitation and Tabulation Procedures; (III) Approving the Form of Ballots and Solicitation Materials; (IV) Establishing the Voting Record Date; (V) Fixing the Date, Time, and Place for the*

Combined Hearing and the Deadline for Filing Objections Thereto; and (VI) Granting Related Relief [Docket No. 197] (the “**Motion**”) filed by the Debtors on June 22, 2021 and the *Order (I) Approving the Combined Disclosure Statement and Plan on an Interim Basis for Solicitation Purposes Only; (II) Establishing Solicitation and Tabulation Procedures; (III) Approving the Form of Ballots and Solicitation Materials; (IV) Establishing the Voting Record Date; (V) Fixing the Date, Time, and Place for the Combined Hearing and the Deadline for Filing Objections Thereto; and (VI) Granting Related Relief* [Docket No. 222] (the “**Solicitation Procedures Order**”), as entered by the Court on May 7, 2020.

5. The Solicitation Packages consist of the following documents:

- a. if applicable, a flash drive (the “**Flash Drive**”) containing the following documents:
 - i. the Combined Disclosure Statement and Plan; and
 - ii. the Solicitation Procedures Order (excluding the exhibits thereto);
- b. if applicable, a printed copy of the appropriate Ballot(s) and voting instructions for the voting class in which the creditor is entitled to vote:
 - i. *Class 7 – Interests Ballot* (the “**Class 7 Ballot**”) (substantially in the form attached as Exhibit 1 to the Solicitation Procedures Order);
 - ii. *Class 7 – Beneficial Holder Ballot* (the “**Beneficial Holder Ballot**”) (substantially in the form attached as Exhibit 2 to the Solicitation Procedures Order);
 - iii. *Class 7 – Master Ballot* (the “**Master Ballot**”) (substantially in the form attached as Exhibit 3 to the Solicitation Procedures Order);
- c. the *Notice of (I) Approval of Combined Disclosure Statement and Plan on an Interim Basis for Solicitation Purposes Only; and (II) the Hearing to Consider (A) Final Approval of the Combined Disclosure Statement and Plan as Containing Adequate Information and (B) Confirmation of the Combined Disclosure Statement and Plan* [Docket No. 226] (the “**Confirmation Notice**”);
- d. if applicable, a pre-addressed, postage prepaid return envelope (the “**Return Envelope**”).
