NOTICE OF WITHDRAWAL OF OBJECTION OF COMMONWEALTH EDISON COMPANY, PSEG LONG ISLAND AND PUBLIC SERVICE ELECTRIC AND GAS COMPANY TO THE DEBTORS’ MOTION SEEKING ENTRY OF INTERIM AND FINAL ORDERS (I) DETERMINING ADEQUATE ASSURANCE OF PAYMENT FOR FUTURE UTILITY SERVICES, (II) PROHIBITING UTILITY PROVIDERS FROM ALTERING, REFUSING, OR DISCONTINUING UTILITY SERVICES, (III) ESTABLISHING PROCEDURES FOR DETERMINING ADEQUATE ASSURANCE OF PAYMENT, AND (IV) GRANTING RELATED RELIEF
