**LIMITED OBJECTION PRIORITY HEALTHCARE DISTRIBUTION, INC D/B/A  
CURASCRIPT SD TO DEBTORS' NOTICE OF PROPOSED ASSUMPTION OR  
ASSUMPTION AND ASSIGNMENT OF CERTAIN EXECUTORY CONTRACTS**

Priority Healthcare Distribution, Inc d/b/a CuraScript SD ("Curascript"), by and through counsel, hereby files this Limited Objection (the "Objection") to Debtor's *Notice to Contract Parties to Potentially Assumed Executory Contracts and Unexpired Leases* (the "Cure Notice")<sup>1</sup>, and respectfully represents as follows:

1. On May 20, 2020 (the "Petition Date"), the Debtor filed a voluntary petition under Chapter 11 of Title 11 of the United States Code (the "Bankruptcy Code").
2. Upon information and belief, Debtor is operating and managing its business as a debtor-in-possession pursuant to Sections 1107 and 1108 of the Bankruptcy Code.
3. Curascript and Debtor entered in that *Product Purchase Agreement* dated May 1, 2009 (the "Agreement"). Under the Agreement, Debtor was to pay to Curascript certain amounts related to the sale of certain products.
4. The Agreement has not been rejected or assumed by Debtor as of the date of this objection.

5. On or about June 20, 2020, Debtors mailed Cure Notice.

**CURE CLAIM OBJECTION**

6. Section 365(b) provides in pertinent part as follows:

(b)(1) If there has been a default in an executory contract or unexpired lease of the debtor, the trustee may not assume such contract or lease unless, at the time of assumption of such contract or lease, the trustee—

- (A) cures, or provides adequate assurance that the trustee will promptly cure, such default...;
- (B) compensates, or provides adequate assurance that the trustee will promptly compensate, a party other than the debtor to such contract or lease, for any actual pecuniary loss to such party resulting from such default; and
- (C) provides adequate assurance of future performance under such contract or lease.

11 U.S.C. § 365(b)(1).

7. As of the date of this Objection, Curascript objects to the cure amounts proposed for the Agreement included in Debtors' Cure Notice (the "Proposed Cure Amount(s)"). Curascript herein reserves the right to file supplementary cure objections.

8. The Proposed Cure as of the date of this Objection matches the amount listed in the Cure Notice.

9. However, Curascript objects to the assumption of the Agreement absent payment of all Cure Amounts owed thereunder from the date of this Objection through the effective date of assumption, including any amounts that will become due or be invoiced on or after August 10, 2020, (including, but not limited to, additional amounts, not yet known, that accrued following the date of this Objection).

**JOINDER**

10. In addition to the foregoing, Curascript further joins in the objections filed by the Debtors' other creditors to the extent that such objections are not inconsistent with the relief requested in this Objection.

### **RESERVATION OF RIGHTS**

11. Curascript hereby reserves its rights to make such other and further objections as may be appropriate to the Agreement, including, but not limited to, objections regarding adequate assurance of future performance under Section 365.

### **CONCLUSION**

12. For the reasons set forth above, Curascript respectfully requests that this Court (i) sustain this Objection; (ii) require that any order authorizing the assumption of the Agreement affirmatively requires the Debtors to pay all amounts accrued but not yet billed following August 10, 2020; and (iii) grant Curascript such further relief as it deems proper.
