**NOTICE OF OPPORTUNITY FOR HEARING**

TAKE NOTICE that on March 15, 2024, the Future Claimants' Representative filed the following applications for interim compensation (together, the "Fee Applications") requesting entry of an Order allowing the Fee Applications as follows:

3. *Eleventh Interim Application of Orrick, Herrington & Sutcliffe LLP for Allowance of Compensation for Services Rendered and Reimbursement of Expenses as Counsel to Joseph W. Grier, III, the Future Claimants' Representative, for the Period of October 1, 2023 through January 31, 2024* seeking approval of interim compensation of \$115,605.00 and reimbursement of expenses of \$730.90.
4. *Tenth Interim Application of Anderson Kill P.C. for Allowance of Compensation for Services Rendered and for Reimbursement of Expenses as Special Insurance Counsel to Joseph W. Grier, III, The Future Claimants' Representative, for the Period of October 1, 2023 through January 31, 2024 seeking approval of interim compensation of \$3,784.00 and reimbursement of expenses of \$0.00.*

3. **If you request a hearing, you or your attorney must** attend the hearing which would be held at **9:30 a.m.** on **April 25, 2024** in Bankruptcy Courtroom 2B at the United States Courthouse, 401 W Trade Street, Charlotte, NC. No hearing will be held unless you request it.

If you or your attorney do not take these steps, the Court may decide that you do not oppose the compensation and reimbursement of expenses as set out above and may enter an order approving the compensation and reimbursement of expenses.
