PLEASE TAKE NOTICE that Dentons US LLP (the “Firm”) hereby amends the *Notice Of Dentons’ Monthly Fee Application For Allowance And Payment Of Interim Compensation And Reimbursement Of Expenses For The Period May 6, 2016 Through June 30, 2019* [Docket No. 496] (the “Notice”) for services rendered for Astria Health and the above-referenced affiliated debtors (collectively, the “Debtors”), in the above-captioned chapter 11 bankruptcy cases (the “Cases”), during the period of May 6, 2019 through June 30, 2019 (the “Application Period”).

These fees and expenses break down as follows:

Period	Fees	Expenses	Total
May 6, 2019 - June 30, 2019	\$629,321.23 <sup>2</sup>	\$1,834.57	\$631,155.80

The Firm seeks allowance of interim compensation in the amount of a total of **\$505,291.55** at this time. This total is comprised as follows: **\$503,456.98** (80% of the fees for services rendered) plus **\$1,834.57** (100% of the expenses incurred).

Pursuant to this Court’s *Order Authorizing Interim Fee Procedures*, entered on or about August 6, 2019 [Docket No. 453], the Debtors are authorized to make the payment requested herein without a further hearing or order of this Court unless an objection to this Application is filed with the Court. The Notice initially filed August 16, 2019 indicated an objection period of ten (10) calendar days after the date of mailing of the Notice of the Application. Dentons hereby amends the Notice to add an additional four (4) days to the objection period. The deadline for

1 parties to object to the Application is August 30, 2019. If such an objection is filed,  
2 the Debtors are authorized to pay 80% of the uncontested fees and 100% of the  
3 uncontested expenses without further order of the Court. If no objection is filed,  
4 the Debtors are authorized to pay 80% of all fees requested in the Application and  
5 100% of the uncontested expenses without further order of the Court.
