PLEASE TAKE NOTICE that Bush Kornfeld LLP (the “Firm”) submitted its Monthly Fee Application (the “Application”) for Allowance and Payment of Interim Compensation and Reimbursement of Expenses for the Period 05/06/19-06/30/19 for work performed as local counsel for the Debtors on August 16, 2019. These fees and expenses break down as follows:

Accordingly, the Firm seeks allowance of interim compensation in the amount of a total of \$52,941.75 at this time. This total is comprised as \$30,323.20 (80% of the fees for services rendered) plus \$22,618.75 (100% of the expenses incurred).

Pursuant to this Court’s *Order on Debtor’s Motion Establishing Procedures For Monthly And Interim Payment Of Fees And Reimbursement*, entered on August 6, 2019 [Dkt. #453], the Debtors are authorized to make the payment requested herein without a further hearing or order of this Court unless an objection to this Application is filed with the Court and served upon the counsel for the Debtor, counsel to the Committee, counsel to the secured creditors, and the U.S. Trustee within fourteen (14) calendar days after the date of mailing of the Notice of the Application, which was August 16, 2019. Therefore, objections to the requested fees are due August 30, 2019. If such an objection is filed, the Debtors are authorized to pay 80% of the uncontested fees and 100% of the uncontested expenses without further order of the Court. If no objection is filed, the Debtors are authorized to pay 80% of all fees requested in the Application and 100% of the uncontested expenses without further order of the Court.
