7 Counsel conferred on July 28, 2020, to discuss the status of the adversary proceeding.
8 Defendants' counsel agreed to provide certain documents to Plaintiffs' counsel relating to the
9 funds at issue so the parties could better evaluate their claims and defenses and possibly reach a
10 settlement. The parties have agreed to extend the deadline for the Defendants to file their
11 responsive pleading by 30 days to August 31, 2020.
