7 *Memorandum of Points and Authorities in Support Thereof* [Docket No. 1473]
8 (the “Motion”) filed by the Debtors on July 7, 2020 and the *Order Granting*
9 *Joint Motion for an Order Approving (I) Disclosure Statement; (II) Solicitation*
10 *and Voting Procedures; (III) Notice Procedures; (IV) Notice and Objection*
11 *Procedures for Confirmation of Joint Plan of Reorganization; and (V) Granting*
12 *Related Relief* [Docket No. 1991] (the “Disclosure Statement Order”), as entered
13 by the Court on November 12, 2020.
