2 **REJECTION OF EXECUTORY AGREEMENTS**

4 1. By Order dated December 23, 2020 [Docket No. 2217] (the
5 "Confirmation Order"), the United States Bankruptcy Court for the Eastern District
6 of Washington (the "Bankruptcy Court") confirmed the *Modified Second Amended*
7 *Joint Chapter 11 Plan of Reorganization of Astria Health and Its Debtor Affiliates*
8 [Docket No. 2196] (including all exhibits thereto, any plan supplement, and as
9 amended, modified, or supplemented from time to time, the "Plan")² filed by Astria
10 Health, a Washington nonprofit public benefit corporation ("Astria"), and the above-
11 referenced affiliated debtors and debtors in possession (collectively, the "Debtors"),
12 in the above-referenced chapter 11 cases (the "Chapter 11 Cases") and Lapis
13 Advisers, LP as lender under the debtor in possession facility in the Chapter 11
14 Cases, agent under the Debtors' prepetition credit agreement, and as investment
15 advisor and investment manager for certain funds which are beneficial holders of
16 those certain Washington Health Care Facilities Authority Revenue Bonds, Series
17 2017a Bonds and the Series 2017b Bonds (collectively the "Lapis Parties" and,
18 together with the Debtors, the "Plan Proponents"), as satisfying the requirements of
19 § 1129 of title 11 of the United States Code, 11 U.S.C. §§ 101 *et seq.* (the
20 "Bankruptcy Code").

1 4. **Rejection of Executory Agreements.** Pursuant to Section IV.B.1 of
2 the Plan, immediately prior to the Effective Date, all Executory Contracts of the
3 Debtors will be deemed rejected in accordance with the provisions and requirements
4 of §§ 365 and 1123 except those Executory Contracts that (i) have been assumed by
5 order of the Court, (ii) are subject to a motion to assume pending on the Effective
6 Date, or (iii) have been identified on a list of assumed contracts to be filed with the
7 Court prior to the Voting Deadline, which shall be a date prior to the Effective Date
8 of the Plan. The Confirmation Order will constitute a Court order approving such
9 rejections of Executory Contracts as of the Effective Date pursuant to §§ 365 and
10 1123.

11 5. **Bar Date for Rejection Damages.** Pursuant to Section IV.B.2 of the
