1 **STIPULATION**

2 This stipulation (the “Stipulation”) is entered into between Astria Health  
3 (“Astria”), a Washington nonprofit corporation, along with the above-referenced  
4 affiliated debtors (collectively, the “Debtors”), the debtors and debtors in possession  
5 in the above-captioned chapter 11 bankruptcy cases (collectively, the “Chapter 11  
6 Cases”), and Banner Bank (collectively, the “Parties”).

7 **RECITALS**

8 1. The Debtors filed voluntary petitions for relief under chapter 11 of title  
9 11 of the United States Code, 11 U.S.C. §§ 101, *et seq.* (“Bankruptcy Code”) on May  
10 6, 2019 (the “Petition Date”).

11 2. On December 4, 2020, Banner Bank filed the *Application of Banner*  
12 *Bank for Allowance of Administrative Expense Claim (Yakima HMA Home Health*  
13 *LLC d/b/a Astria Home Health & Hospice - Yakima)* [Docket No. 2071] and the  
14 *Application of Banner Bank for Allowance of Administrative Expense Claim (SHC*  
15 *Medical Center Toppenish dba Astria Toppenish Hospital)* [Docket No. 2074] (the  
16 “Applications”), along with its notices [Docket Nos. 2073 and 2075] (the “Notices”),  
17 which set December 28, 2020 as the deadline to object to the Applications.

18 3. The Parties, by previous stipulation [Docket No. 2222], agreed to extend  
19 the deadline to object to the Applications until January 6, 2021 (the “Reply  
20 Deadline”).
