As you know, it has been over one year since Astria Regional Medical Center ("Astria") filed for bankruptcy, and several months since the hospital closed. Since that time, our Union has worked hard to get the best possible outcome for our members. We'd like to bring you up to date on the status of the money owed to you by Astria.

We submitted a bankruptcy claim on behalf of all SEIU 1199NW Astria employees for any paid time off owed to eligible members (those with at least 1 year of service) and for Astria's failure to give notice of layoff. In order to pursue these claims, we need to confirm your date of hire, rate of pay and how much paid time off you had accrued but not used at the time you were laid off. The following information comes from Astria's records:
