1 This matter came before the court on *The GUC Distribution Trustee's*  
2 *Second Omnibus Claims Objection (Satisfied Claims)* (the "Objection").  
3 Capitalized terms not defined in this Order shall have their meanings as set forth in  
4 the Objection.

5 This court has found that it has jurisdiction over this matter pursuant to 28  
6 U.S.C. §§ 157 and 1334 and has authority to enter a final order consistent with  
7 Article III of the United States Constitution; that venue of this proceeding and the  
8 Objection in this district is proper pursuant to 28 U.S.C. §§ 1408 and 1409; and  
9 that the notice of the Objection was appropriate under the circumstances and no  
10 other notice need be provided. Having reviewed the Objection and all documents  
11 filed in support of or opposition thereto; having heard the statements of counsel at  
12 any hearing before this court; and upon the record in this matter; and after due  
13 deliberation thereon; and this court having determined that just cause has been  
14 established for the relief granted herein, it is hereby **ORDERED** as follows:

- 15 1. The Objection [ECF No. 2751] is granted as set forth herein.
- 16 2. Any response to the Objection that has not otherwise been withdrawn  
17 or resolved, or with respect to which the hearing on the Objection has not been  
18 adjourned, is hereby overruled.
- 19 3. The Claims<sup>1</sup> identified on Exhibit A attached to the Objection are  
20 hereby disallowed and expunged in their entirety.

21 <sup>1</sup> For the avoidance of doubt, the term "Claims" as used in this Order refers only to the "General Unsecured" portions of the claims identified on Exhibit A attached to the Objection.

1           4.     The official claims register shall be modified in accordance with this  
2 Order.

3           5.     The objection to each Claim addressed in the Objection constitutes a  
4 separate contested matter as contemplated by Bankruptcy Rule 9014. This Order  
5 shall be deemed a separate order with respect to each Claim. Any stay of this Order  
6 pending appeal by any of the claimants subject to this order shall only apply to the  
7 contested matter that involves such claimant and shall not act to stay the  
8 applicability and/or finality of this Order with respect to the other contested matters  
9 addressed hereby.

10          6.     All rights of the GUC Distribution Trustee and the Reorganized  
11 Debtors to object to any claim (including the claims that are the subject of the  
12 Objection) at a later date on any basis whatsoever are reserved and preserved.

13          7.     All rights of the GUC Distribution Trustee and the Reorganized  
14 Debtors to use any available defenses, under section 502 of the Bankruptcy Code or  
15 otherwise, and to setoff or recoup against or otherwise reduce all or any part of any  
16 claim (including the claims that are the subject of the Objection) are reserved and  
17 preserved.

18          8.     The terms and conditions of this Order shall be effective and  
19 enforceable immediately upon its entry.
