7	2. The Reorganized Debtor's request for an order directing that these								
8	Secured and/or Priority Claims be reflected as fully satisfied on the official claims								
9	register [ECF No. 2791] is granted.								
10	3. The Clerk of the Court and any applicable third-party claims agent are								
11	authorized and directed to update the Claims Register to reflect the Secured and/or								
12	Priority Claims listed on Exhibit A as fully satisfied.								
13	4. Notwithstanding the foregoing, to the extent any Claimant identified in								
14	Exhibit A asserts that the treatment identified in Exhibit A resulted in the								
15	reclassification of some or all of its Secured and/or Priority Claim(s) to general								
16	unsecured claim status, such Claimant is hereby directed to amend their proof of								
17	claim to reflect such assertion no later than thirty (30) days from the date of this								
18	Order, or forever be barred, estopped, and enjoined from asserting such								
19	reclassification to general unsecured claim status.

Notwithstanding the relief granted in this Order or any actions taken 6. 4 pursuant to such relief, nothing in this Order shall (a) constitute an allowance of any 5 general unsecured claim held by a Claimant not otherwise previously allowed, 6 including any claims that were reclassified; (b) be deemed a waiver of the 7 Reorganized Debtor's rights to amend, modify or supplement the Notice or file a new 8 objection to assert additional objections to the claim or any other proofs of claim 9 (filed or not) that may be asserted by the Claimants, which rights are expressly 10 reserved and hereby preserved; or (c) be deemed a waiver of any of the Reorganized 11 Debtor's and the GUC Distribution Trustee's rights, claims, defenses, causes of 12 action and/or objections, including, without limitation, objections to any general 13 unsecured claims asserted by such the Claimants, which are expressly reserved and 14 hereby preserved. 15

7. Notwithstanding the possible applicability of Bankruptcy Rules 6004(h),
 7062, 9014 or otherwise, the terms and conditions of this Order shall be immediately
 effective and enforceable upon its entry.
