LIMITED OBJECTION TO DEBTORS' EMERGENCY MOTION FOR ENTRY OF AN ORDER (1) RESETTING THE COMBINED HEARING DATE AND (11) EXTENDING CERTAIN DEADLINES RELATED THERETO [Relates to Doc. No. 607]

Olaya Z. Goodman ("Goodman"), a creditor in this action, files this limited objection to the Debtors' motion for entry of an order (I) resetting the combined hearing date and (II) extending certain deadlines related thereto asserting that given the request of the Debtors' that the Plan Supplement deadline be extended that the deadline for the objection to the final approval of the disclosure statement and Plan and voting deadline should be correspondingly extended to June 13, 2023. In further support Goodman states as follows:

- Ms. Goodman is a plaintiff in litigation with the Debtor. She suffered a work related motor vehicle crash and suffered severe injuries to her neck, back and bilateral shoulders and was disabled from working.
- The original deadlines in the case anticipated the Plan Supplement being filed before the voting and objection deadlines for the final approval of the disclosure statement and Plan.
- 3. Goodman's counsel reached out to Debtor's counsel inquiring about the Plan Supplement on May 23, 2023 and raised other questions related to the Plan. The Debtors have not had an opportunity to respond to that inquiry as of this date.



- On May 24, 2023, the Debtor filed a motion to extend the deadline for filing the Plan Supplement.
- 5. Goodman's counsel reached out to Debtor's counsel seeking an agreement that the voting and objection deadline also be correspondingly extended. Debtor's counsel has not had an opportunity to respond as of the filing of this objection.
- 6. Goodman respectfully requests that the voting and objection deadline be extended for her to June 12, 2023 to provide an opportunity to review the full plan and liquidation analysis before objection in order to prevent the need to file a protective objection and then file a supplement or amendment after the Debtor files its exhibits to the Plan and Plan Supplement.
- 7. Goodman proposes the following changes in red:
