Period, and (c) reimbursement of 100% of the actual and necessary expenses incurred by Jefferies during the Compensation Period in connection with its services to the Committee in the amount of \$4,804.42. In support of this Fee Statement, Jefferies respectfully represents as follows:

Jurisdiction and Venue

1. The United States Bankruptcy Court for the Southern District of New York (the "<u>Court</u>") has jurisdiction over this matter pursuant to 28 U.S.C. § 1334. This matter is a core proceeding within the meaning of 28 U.S.C. § 157(b)(2). Venue of this matter is proper pursuant to 28 U.S.C. §§ 1408 and 1409.

Background

2. On May 10, 2020 (the "<u>Petition Date</u>"), each of the Debtors filed a voluntary petition with this Court for relief under chapter 11 of title 11 of the United States Code (the "Bankruptcy Code").

3. On May 22, 2020, the United States Trustee for Region 2 (the "<u>U.S. Trustee</u>") appointed a Committee pursuant to section 1102 of the Bankruptcy Code [Docket No. 154]. Shortly after its appointment, the Committee selected Jefferies as its investment banker.

4. On July 1, 2020, the Committee filed an application to employ and retain Jefferies as its investment banker under sections 328(a) and 1103(a) of the Bankruptcy Code, effective as of May 24, 2020, pursuant to the terms and subject to the conditions of that certain engagement letter (the "Engagement Letter") between Jefferies and the Committee dated as of May 24, 2020 [Docket No. 374] (the "<u>Retention Application</u>").²

5. On July 14, 2020, the Court entered the order granting the Retention Application [Docket No. 462] (the "<u>Retention Order</u>"), effective as of May 24, 2020. The Retention Order, among other things, authorized the Debtors to pay, reimburse, and indemnify Jefferies in accordance with the terms and conditions of the Engagement Letter, subject to application to the Court. A copy of the Engagement Letter was annexed to the Retention Order as Exhibit 1.

6. On June 9, 2020, the Court entered the Order Establishing Procedures for Interim Compensation and Reimbursement of Expenses for Professionals [Docket No. 256] (the "Interim Compensation Order"), which generally sets forth the procedures for interim compensation and expense reimbursement for all retained professionals in these cases. The Interim Compensation Order provides that each professional shall, on before the 30th day of each calendar month following the month for which compensation is sought, file and serve a statement requesting allowance and payment of compensation for services rendered and reimbursement of expenses incurred during the preceding month (each a "Monthly Fee Statement"). If a professional fails to file a Monthly Fee Statement for a particular month or months, that profesional may subsequently submit a consolidated Monthly Fee Statement that includes those previous months. Parties shall have 15 days following the filing of a Monthly Fee Statement to object to such Monthly Fee Statement (the "Objection Deadline"). At the expiration of the Objection Deadline, the Debtors shall promptly pay 80% of the fees and 100% of the expenses requested in the applicable Monthly Fee Statement to which no objection has been served.

Relief Requested

7. By this Fee Statement, Jefferies requests (a) interim allowance of compensation for professional services rendered on behalf of the Committee during the Compensation Period in the amount of \$175,000.00, (b) payment in the amount of \$140,000.00, which is equal to 80% of Jefferies' unpaid fees earned during the Compensation Period, and (c) reimbursement of 100% of

the actual and necessary expenses incurred by Jefferies during the Compensation Period in connection with its services to the Committee in the amount of \$4,804.42.

8. All services for which compensation is requested by Jefferies were performed during the Compensation Period on behalf of the Committee. Although Jefferies, in line with market convention, does not bill by the hour, Jefferies kept track of its post-petition time in half-hour increments in accordance with the Retention Order. Such time records are attached hereto as **Exhibit A**. During the Compensation Period, Jefferies professionals spent approximately 315 hours providing investment banking services to the Committee.

9. The fees charged by Jefferies have been billed in accordance with the Engagement Letter and the Retention Order and are comparable to those fees charged by Jefferies for professional services rendered in connection with similar chapter 11 cases and non-bankruptcy matters. Jefferies submits that such fees are reasonable based upon the customary compensation charged by similarly skilled practitioners in comparable bankruptcy cases and non-bankruptcy matters in the competitive national investment banking market.

Actual and Necessary Expenses

10. Jefferies also incurred certain necessary expenses during the Compensation Period for which it is entitled to reimbursement under the Engagement Letter. As set forth in greater detail in the summary attached hereto as <u>**Exhibit B**</u>, Jefferies' total expenses incurred during the Compensation Period are $$4,804.42.^3$


