CERTIFICATION OF P. JOSEPH MORROW IV WITH RESPECT TO THE TABULATION OF VOTES ON THE JOINT CHAPTER 11 PLAN OF AVIANCA HOLDINGS S.A. AND ITS AFFILIATED DEBTORS

I, P. Joseph Morrow IV, depose and say under the penalty of perjury:

1. I am a Vice President of Corporate Restructuring Services, employed by Kurtzman Carson Consultants LLC ("KCC"), located at 222 N. Pacific Coast Highway, 3rd Floor, El Segundo, California 90245. I am over the age of 18 and not a party to these proceedings.

The debtors in these chapter 11 cases, and each Debtor's federal tax identification number (to the extent applicable), are as follows: Avianca Holdings S.A. (N/A); Aero Transporte de Carga Unión, S.A. de C.V. (N/A); Aeroinversiones de Honduras, S.A. (N/A); Aerovías del Continente Americano S.A. Avianca (N/A); Airlease Holdings One Ltd. (N/A); America Central (Canada) Corp. (00-1071563); America Central Corp. (65-0444665); AV International Holdco S.A. (N/A); AV International Holdings S.A. (N/A); AV International Investments S.A. (N/A); AV International Ventures S.A. (N/A); AV Investments One Colombia S.A.S. (N/A); AV Investments Two Colombia S.A.S. (N/A); AV Loyalty Bermuda Ltd. (N/A); AV Taca International Holdco S.A. (N/A); Aviacorp Enterprises S.A. (N/A); Avianca Costa Rica S.A. (N/A); Avianca Leasing, LLC (47-2628716); Avianca, Inc. (13-1868573); Avianca-Ecuador S.A. (N/A); Aviaservicios, S.A. The Debtors' principal offices are located at Avenida Calle 26 # 59 – 15 Bogotá, Colombia.



- 2. James Lee, Vice President of Public Securities Services, assisted in the solicitation and tabulation described herein.
- 3. The Court authorized the retention of KCC (i) as the claims and noticing agent to the Debtors pursuant to the Order Authorizing Retention and Appointment of KCC as Claims and Noticing Agent Under 28 U.S.C. § 156(c), 11 U.S.C. § 105(a), and S.D.N.Y. L.B.R. 5075-1 Nunc Pro Tunc to the Petition Date and Granting Related Relief [Docket No. 52] entered on May 13, 2020 and (ii) as administrative advisor to the Debtors pursuant to the Order Authorizing Debtors to Retain Kurtzman Carson Consultants LLC as Administrative Advisor Effective Nunc Pro Tunc to the Petition Date [Docket No. 258] entered on June 9, 2020 (collectively, the "Retention Orders"). The Retention Orders authorize KCC to assist the Debtors with, among other things, the service of solicitation materials and tabulation of votes cast to accept or reject the Plan. KCC and its employees have considerable experience in soliciting and tabulating votes to accept or reject proposed chapter 11 plans.

A. Service and Transmittal of Solicitation Packages and Related Information

4. On September 15, 2021, the Court entered the Order (I) Approving the Disclosure Statement; (II) Approving Solicitation and Voting Procedures; (III) Approving Forms of Ballots; (IV) Establishing Procedures for Allowing Certain Claims for Voting Purposes; (V) Scheduling a Confirmation Hearing; and (VI) Establishing Notice and Objection Procedures [Docket No. 2136] (the "Disclosure Statement Order"). The Disclosure Statement Order established, among other things, (i) September 9, 2021 as the record date (the "Voting Record Date") for determining the Holders of Claims and Interests entitled to vote on the Plan, (ii) procedures for the solicitation of votes to accept or reject the Plan (the "Solicitation Procedures") and

Capitalized terms used but not otherwise defined herein shall have the same meanings ascribed to them in the Disclosure Statement Order.

- (iii) procedures for the tabulation of Ballots (the "<u>Tabulation Procedures</u>"). Pursuant to the Plan and the Solicitation Procedures, only holders of Claims as of the Voting Record Date in Class 3 (Engine Loan Claims), Class 4 (Secured RCF Claims), Class 7 (Grupo Aval Lines of Credit Claims), Class 11 (General Unsecured Avianca Claims), and Class 15 (General Unsecured Convenience Claims) (collectively, the "<u>Voting Classes</u>") were entitled to vote to accept or reject the Plan.
- 5. In accordance with the Disclosure Statement Order, on September 22, 2021, KCC caused to be served (i) the Confirmation Hearing Notice on the parties listed in the creditor matrix and all other parties entitled to receive such notice pursuant to the Disclosure Statement Order, (ii) the Solicitation Packages on all Holders of Claims in the Voting Classes entitled to vote as of the Voting Record Date, (iii) the applicable Non-Voting Status Notice in lieu of Solicitation Packages to the holders of Claims and Interests in the following Classes (which were not entitled to vote on the Plan): Class 1 (Priority Non-Tax Claims), Class 2A (Other Secured Claims), Class 5 (USAV Receivable Facility Claims), Class 6 (Grupo Aval Receivable Facility Claims), Class 8 (Grupo Aval Promissory Note Claims), Class 9 (Cargo Receivable Facility Claims), Class 10 (Pension Claims), Class 12 (General Unsecured Avifreight Claims), Class 13 (General Unsecured Aerounión Claims), Class 14 (General Unsecured SAI Claims), Class 16 (Subordinated Claims), Class 17 (Intercompany Claims), Class 18 (Existing AVH Non-Voting Equity Interests), Class 19 (Existing AVH Common Equity Interests), Class 20 (Existing Avifreight Equity Interests), Class 21 (Existing SAI Equity Interests), Class 22 (Other Existing Equity Interests), Class 23 (Intercompany Interests), as well as holders of Claims that are subject to a pending objection. Additionally, on September 28, 2021, KCC caused to be served the Supplemental Confirmation Hearing Notice on the parties listed in the creditor matrix and all

other parties entitled to receive such notice pursuant to the Disclosure Statement Order. KCC filed the *Certificate of Mailing of Claims Agent re: Solicitation Materials* [Docket No. 2197] with the Court on October 9, 2021 evidencing the foregoing.

- 6. On September 22, 2021, KCC also posted links to the electronic versions of the solicitation materials, including the Confirmation Hearing Notice, Plan, Disclosure Statement, Disclosure Statement Order, Cover Letter from the Debtors, Committee Recommendation Letter, and Non-Voting Status Notices on the public access website at www.kccllc.net/avianca.
- 7. On September 24, 2021 the Confirmation Hearing Notice was published in *The New York Times (National Edition)*, *USA Today, El Diario de Hoy, Diario de Comercio, Diario la República, El Tiempo, and La República*. Affidavits evidencing the publication of the Confirmation Hearing Notice were filed with the Court on October 8, 2021 [Docket Nos. 2195, 2196].

B. Voting and Tabulation Process

- 8. The Disclosure Statement Order established September 9, 2021 as the Voting Record Date. Pursuant to the Disclosure Statement Order, holders of Claims in Class 3 (Engine Loan Claims), Class 4 (Secured RCF Claims), Class 7 (Grupo Aval Lines of Credit Claims), Class 11 (General Unsecured Avianca Claims), and Class 15 (General Unsecured Convenience Claims) were entitled to vote to accept or reject the Plan. No other classes were entitled to vote on the Plan.
- 9. Pursuant to the Disclosure Statement Order, KCC relied on the Debtors' Schedules of Assets and Liabilities and the Claims information reflected in KCC's CaseView ("CaseView")³ to identify and solicit holders of Claims in the Voting Classes. The information

³ CaseView is KCC's claims management database, which stores the records and images associated with all scheduled and filed claims.

pertaining to the holders of Claims in Class 4 (Secured RCF Claims) was provided to KCC by counsel to the Secured RCF Agent.

- 10. KCC also relied on security position reports provided by The Depository Trust Company ("DTC") as of the Voting Record Date to identify the bank and brokerage firms (the "Nominees") that held Class 11 Claims on behalf of underlying beneficial owners who that entitled to vote to accept or reject the Plan.
- 11. Using the information outlined above, and with specific guidance from the Debtors' advisors, KCC created a voting database reflecting the names and addresses of holders of Claims and Interests, the classification of Claims and Interests, and voting amounts in the Voting Classes. Specifically, using its CaseView system and voting database, KCC generated ballots for holders of Claims entitled to vote to accept or reject the Plan.
- 12. For the 2020 Notes Claims and 2023 Notes Claims in Class 11, KCC provided Solicitation Packages to the Nominees appearing on the security position report received from DTC (or the Nominees' agents) for subsequent forwarding to the underlying beneficial owners of the 2020 Notes Claims and 2023 Notes Claims. KCC also provided a Master Ballot to each Nominee (or its agent) for their use in reporting the voting of the underlying beneficial owners.
- 13. The Disclosure Statement Order established October 15, 2021 at 4:00 p.m. (prevailing Eastern Time) as the deadline by which ballots for accepting or rejecting the Plan had to be actually received by KCC in order to be counted (the "<u>Voting Deadline</u>"), except to the extent such Voting Deadline was extended by the Debtors in writing in their sole discretion.
- 14. In accordance with the Disclosure Statement Order, KCC received and tabulated Ballots as follows: (a) each returned paper Ballot was opened and inspected at KCC's office; (b) paper Ballots were date-stamped and scanned into KCC CaseView; (c) each electronic Ballot

was electronically received and processed; and (d) all Ballots received on or before the Voting Deadline were then entered into KCC CaseView and tabulated or, in the case of Class 11 Master Ballots, tabulated against the security position amounts appearing for each Nominee as listed on the security position reports received from DTC and tabulated in accordance with the Voting and Tabulation Procedures.

- 15. The final tabulation of votes cast by timely and properly completed ballots received by KCC is attached hereto as **Exhibit A**. The detailed ballot reports for the Voting Classes are attached hereto as **Exhibits A-1** through **A-6**.
- 16. In addition, in accordance with the Solicitation and Voting Procedures, KCC reviewed and tabulated the elections recorded on the opt-out forms received by the Voting Deadline from holders of Claims or Interests entitled to opt out of the Plan's Third-Party Release (or from the Nominees of such Holders). A report of any such holders that checked the opt-out box on their ballots or opt-out forms is attached hereto as **Exhibit B**. For the avoidance of doubt, this Certification does not certify the validity or enforceability of any opt-out elections received and reported on **Exhibit B** hereto, but rather this Certification is providing such information for reporting and informational purposes.

C. Ballots That Were Not Counted

17. Attached as **Exhibit C** to this Certification is a detailed report of any Ballots that were not included in the tabulation above because they did not satisfy the requirements for a valid Ballot as set forth in the Disclosure Statement Order.

D. Conclusion

18. To the best of my knowledge, information and belief, the foregoing information concerning the distribution, submission, and tabulation of Ballots in connection with the Plan is
