For value received, the adequacy and sufficiency of which are hereby acknowledged, **MAPS 2019-1 LIMITED** (the “Seller”), hereby unconditionally and irrevocably sells, transfers and assigns to **CITIGROUP FINANCIAL PRODUCTS INC.** (the “Buyer”) all (100%) of Seller’s right, title, interest, claims and causes of action in and to, or arising under or in connection with, Seller’s unsecured claim (as such term is defined in Section 101(5) of the U.S. Bankruptcy Code), allowed in the Bankruptcy Case (as defined below) in the original liquidated face claim amount of \$38,048,945.00, that was asserted against Aerovías del Continente Americano S.A. Avianca (the “Debtor”), a debtor in the Chapter 11 case captioned In re: Avianca Holdings S.A., et al., jointly administered under Case No. 20-11133 (the “Bankruptcy Case”) pending in the United States Bankruptcy Court for the Southern District of New York (the “Bankruptcy Court”), and any and all other proofs of claim filed by Seller with the Bankruptcy Court in respect of the foregoing claim (collectively, the “Prepetition Stipulation Claim”).

Seller hereby waives any objection to the transfer of the claim to Buyer on the books and records of the Debtor and the Bankruptcy Court, and hereby waives to the fullest extent permitted by law any notice or right to a hearing as might be imposed by Rule 3001 of the Federal Rules of Bankruptcy Procedure, the Bankruptcy Code, applicable local bankruptcy rules or applicable law. Seller acknowledges and understands, and hereby stipulates, that an order of the Bankruptcy Court may be entered without further notice to Seller transferring to Buyer the foregoing claim and recognizing Buyer as the sole owner and holder of the claim. Seller further directs the Debtor, the Bankruptcy Court, and all other interested parties that all further notices relating to the claim, and all payments or distributions of money or property in respect of the claim, are to be delivered or made to Buyer.
