STATEMENT OF ISSUE ON APPEAL

Whether the bankruptcy court erred in holding that brokerage fees owed by the Reorganized Debtors in connection with pre-petition lease transactions, which fees became unconditional obligations upon execution of the leases, but were scheduled to be paid in installments over the term of the leases—including during the post-petition period—are entitled to priority under section 365(d)(5) of the Bankruptcy Code as obligations "arising . . . after the bankruptcy filing."
