7 Counsel to above-captioned Debtors (collectively, the "Debtors") met and conferred with 8 counsel United Nurse Associations of California/Union of Health Care Professionals 9 ("UNAC/UHCP"), the union counterparty to the Debtors' collective bargaining agreement 10 regarding the Debtors' Emergency Motion for Entry of Interim and Final Orders (I) Authorizing 11 the Debtors to (A) Pay Prepetition Wages, Salaries, and Other Compensation, and (B) Continue 12 Employee Benefits Programs, and (II) Granting Related Relief [Dkt. No. 11] (the "Wages Motion") 13 and UNAC/UHCP's reservation of rights to the Wages Motion. See UNAC/UNCP's Reservation 14 of Rights Regarding Debtors' Emergency Motion for Entry of Interim and Final Orders (I) 15 *Authorizing Debtors to (A) Pay Prepetition Wages, Salaries and, and Other Compensation, and (B)* 16 Programs, and (II) Granting Related Relief [Dkt No.250] (the "Reservation of Rights"). 17 UNAC/UHCP was the only party to file a response to the Wages Motion. In support of this Stipulation, the Parties refer to the following recitals:

A. WHEREAS, on April 19, 2023 (the "<u>Petition Date</u>") the Debtors filed voluntary chapter 11 petitions initiating their chapter 11 cases under 11 U.S.C. § 101 et seq. On April 21, 2023, this Court entered an order directing procedural consolidation and joint administration of the Debtors' chapter 11 cases. The Debtors are operating their business and managing their properties as debtors in possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code. No request for the appointment of a trustee or examiner has been made in these chapter 11 cases.

B. WHEREAS, on April 21, 2023, the Court held a first day hearing to consider the
 Debtors' emergency first day motions, including the *Debtors' Emergency Motion for Entry of Interim and Final Orders (I) Authorizing Debtors to (A) Pay Prepetition Wages, Salaries, and Other Compensation and (B) Continue Employee Benefits, and (II) Granting Related Relief* [Dkt.
 No. 11] (the "<u>Wages Motion</u>").

C. WHEREAS, on April 21, 2023, the Court entered an interim order on the Wages
Motion, which granted interim relief and set an objection deadline to the Wages Motion for May 3,
2023, and set a final hearing on the Motions for May 17, 2023 at 9:00 a.m. (prevailing Pacific
Time).

D. WHEREAS, pursuant to certain stipulations filed and granted by the Court,
UNAC/UHVP's deadline to object to the Wages Motion was extended to May 12, 2023 before
12:00 p.m. (Pacific Time). See Order Approving Stipulation to Continue Second Day Hearings *from May 17, 2023 at 9:00 a.m. to May 24, 2023 at 9:00 a.m.*

E. WHEREAS, on May 12, 2023, UNAC/UHCP filed UNAC/UHCP's Reservation of *Rights Regarding Debtors' Emergency Motion for Entry of Interim and Final Orders (I) Authorizing Debtors to Pay Prepetition Wages, Salaries, and other Compensation, and (B) Continue Employee Benefit Programs, and (II) Granting Related Relief* [Dkt. No. 250] (the
"Reservation of Rights").

F. WHEREAS, the Debtors and UNAC/UHCP reached an agreement to add certain
language to the Debtors' proposed order resolving the UNAC/UHCP's Reservation of Rights and
granting the Wages Motion on a final basis.

G. WHEREAS, attached to this Stipulation as <u>Exhibit A</u> is a redline showing the
additional negotiated language to the Debtors initially-filed proposed order granting the Wages
Motion on a final basis.


