**DECLARATION OF STEVEN D. SASS ON BEHALF OF STEVEN D SASS
LLC, LIQUIDATING TRUSTEE IN SUPPORT OF MOTION OF THE
LIQUIDATING TRUSTEE FOR AN ORDER DEEMING CERTAIN
HOLDERS OF UNSECURED CLAIMS UNDER THE PLAN TO HAVE
WAIVED THEIR RIGHT TO RECEIVE DISTRIBUTIONS**

I, Steven D. Sass, sole member of Steven D Sass LLC hereby declare
that the following is true and correct to the best of my knowledge, information, and
belief.

1. Steven D Sass LLC is the liquidating trustee (the "Liquidating
Trustee") of the Blitz Liquidating Trust. I am the sole member of Steven D Sass
LLC. In the course and scope of my engagement, I have been personally involved
in the processing the claims against Blitz U.S.A., Inc., and its affiliated debtors in the
above-captioned cases, as debtors and debtors in possession (collectively, the
"Debtors"). I am authorized to submit this Declaration on behalf of the Blitz
Liquidating Trust.

2. Except as otherwise set forth herein, all statements in this Declaration are based on my personal knowledge and my familiarity with Motion of the Liquidating Trustee for an Order Deeming Certain Holders of Unsecured Claims Under the Plan to Have Waived their Right to Receive Distributions (the “Motion”)² filed on April 14, 2015 [Docket No. 2429]. If called upon to testify, I could and would competently testify to the facts set forth herein. I submit this Declaration in support of the Motion.

3. Pursuant to the Motion, the Blitz Liquidating Trust seeks entry of an order providing that any of the creditors identified on Schedule 1 attached thereto, which are holders of Claims (the “Claimants”), classified as Class 3(a) (General Unsecured Claims against the USA Debtors) under the Plan (as defined below) that failed to provide a taxpayer identification number within thirty (30) of service of the order, will be deemed to have waived its right to receive any distributions in these cases.

4. Prior to filing the Motion, I along with certain individuals under my direction, made multiple attempts to contact the Claimants to obtain the proper taxpayer identification information. As set forth in the Motion, the Liquidating Trust is required to comply with the applicable tax withholding and reporting requirements pursuant to the Trust Agreement and federal tax law.

Accordingly, the Claimants were contacted to provide the proper taxpayer identification information prior to receiving any distribution.

5. On May 16, 2014, the Claimants listed on Exhibit A attached hereto (the “Non-Legal Claimants”) received the letter attached hereto as Exhibit B (the “First Request”). Subsequently, I along with certain individuals under my direction caused another letter request to be mailed on June 9, 2014 (the “Second Request”) to the Non-Legal Claimants. The Second Request is attached hereto as Exhibit C.

6. Additionally, on November 6, 2014, I along with certain individuals under my direction caused a letter request to be mailed to the claimants listed on Exhibit D hereto (the “Legal Claimants,” together with the Non-Legal Claimants, the Claimants). A copy of the letter (the “Legal Request”) is attached hereto as Exhibit E.

7. The First Request, Second Request and Legal Request were (i) mailed to each Claimant at each address that the Liquidating Trustee had for the Claimants and (ii) re-mailed to new addresses for the Claimants provided by the U.S. Postal Service.

8. As of the filing of the Motion, April 14, 2015, taxpayer identification information had not been received from the Claimants. Since the filing of the motion, however, there have been several Claimants who have forwarded appropriate taxpayer identification material and who, as a result, will receive distribution.

9. The Motion provided the Claimants an additional thirty (30) days to supply the required taxpayer identification information (the "Final Request"). Each of the Claimants subject to the Motion received two (2) requests for the taxpayer information, and the Non-Legal Claimants have received three (3) requests.

CONCLUSION

For the reasons set forth herein and in the Motion, the Liquidating Trustee respectfully requests that the Motion be granted. I declare under penalty of perjury under the laws of the United States of America that the foregoing is true and correct.
