- 1. <u>Confirmation of the Plan</u>. - 2. <u>Effective Date</u>. The Effective Date of the Plan occurred on March 20, 2014. Each of the conditions precedent to consummation of the Plan enumerated in section 11.2 of the Plan have been satisfied and/or waived as provided in section 11.5 of the Plan.
- 3. **Release, Exculpation, and Injunction**. Pursuant to the Confirmation Order, the release, injunction and exculpation provisions in Articles VII and XV of the Plan are now in full force and effect.
- 4. <u>Bar Date for Administrative Expense Claims</u>. than **May 5, 2014** ("<u>Administrative Claims Bar Date</u>"), unless otherwise ordered by the Bankruptcy Court. Objections to any Administrative Expense Claims must be filed by **June 4, 2014**, which objection date may be extended by application to the Bankruptcy Court.

- 5. **Bar Date for Professional Claims.** In accordance with the section 2.3 of the Plan, Bankruptcy Professionals requesting compensation or reimbursement of expenses pursuant to sections 327, 328, 330, 331, 503(b) or 1103 of the Bankruptcy Code for services rendered during the Chapter 11 Cases (including, without limitation, any compensation requested by any Bankruptcy Professional or any other Entity for making a substantial contribution to the Chapter 11 Cases), shall file with the Bankruptcy Court, an application for final allowance of compensation and reimbursement of expenses on or before the Administrative Claims Bar Date.
