## APPLICATION REQUESTING STATUS CONFERENCE I. INTRODUCTION

Borrego Community Health Foundation, the debtor and debtor in possession 3 4 (the "Debtor") in the above-captioned chapter 11 bankruptcy case by and through its undersigned counsel, hereby files this Application Requesting Status Conference (the 5 6 "Application") seeking a status conference (the "Status Conference") on the afternoon of February 15, 2023, or as otherwise convenient for the Court, relating to 7 status of the Debtor's sale efforts and the deadlines in the order (the "Bidding 8 9 Procedures Order") [Docket No. 321] granting the *Debtor's Motion For The Entry* of (I) An Order (1) Approving Form Of Asset Purchase Agreement; (2) Approving 10 Auction Sale Format and Bidding Procedures, (3) Approving Process For 11 Discretionary Selection Of Stalking Horse Bidder And Bid Protections; (4) 12 Approving Form Of Notice To Be Provided To Interested Parties; (5) Scheduling A 13 *Court Hearing To Consider Approval Of The Sale To The Highest And Best Bidder;* 14 And (6) Approving Procedures Related To The Assumption Of Certain Executory 15 Contracts And Unexpired Leases; And (II) An Order Authorizing The Sale Of 16 *Property Free And Clear Of All Claims, Liens And Encumbrances* [Docket No. 161] 17 (the "Motion").<sup>1</sup> In support of the Application, the Debtor respectfully submits as 18 follows: 19

## II. <u>REQUEST</u>

On February 9, 2023, the Debtor filed the *Notice of Adjourned Auction* [Docket
No. 438] informing the Court and interested parties that the Debtor adjourned the
Auction to receive further instructions from the Debtor's Board of Trustees and to
best promote the goals of the bidding process. The Debtor further requested final
highest and best bids by February 10, 2023, at 12:00 p.m. PST (the "<u>Final Bids</u>").
The Debtor has received the Final Bids and is in the process of reviewing the Final

Bids. The Debtor anticipates filing a notice of Winning Bidder prior to the requested
 Status Conference.

Given that the notice of auction results had not yet been filed, on February 10, 3 2023, the Court entered its Order Vacating Deadline for Objections to Sale [Docket 4 No. 443] vacating the deadline set by the Bidding Procedures Order to file objections 5 to the Sale due to the adjourned Auction. The Debtor, in consultation with the 6 7 Official Committee of Unsecured Creditors, requests that Court schedule a Status Conference to discuss the current deadlines and hearing date. The Debtor anticipates 8 9 only a slight delay from its original timeline and remains committed to an expedient sale process due to (i) the Sale's contingency on HRSA approval of the Winning 10 Bidder—which may take up to six months—and (ii) the Debtor's liquidity concerns. 11 Accordingly, a Status Conference will facilitate the goals of an expedited sale 12 process. 13

## III. <u>CONCLUSION</u>

Wherefore, based on the foregoing, the Debtor respectfully requests that the Court enter an order (i) granting this Application, (ii) scheduling a Status Conference on February 15, 2023, after 1:00 p.m. PST; and (iii) granting such other and further relief as is just and proper under the circumstances.
