I, Sydney Reitzel, depose and say under the penalty of perjury:

1. I am a Director of Corporate Restructuring Services employed by
Kurtzman Carson Consultants LLC ("<u>KCC</u>"), located at 222 North Pacific Coast
Highway, Suite 300, El Segundo, California 90245. I am over the age of 18 and not a
party to this action.

6 2. I submit this voting certification with respect to the solicitation of votes 7 and the tabulation of ballots cast on the First Amended Joint Combined Disclosure 8 Statement and Chapter 11 Plan of Liquidation of Borrego Community Health 9 Foundation [Docket No. 1168] (the "Plan").<sup>1</sup> Except as otherwise noted, all facts set 10 forth herein are based on my personal knowledge, knowledge that I acquired from 11 individuals under my supervision, and/or my review of the relevant documents. I am 12 authorized to submit this voting certification on behalf of KCC. If I were called to 13 testify, I could and would testify competently as to the facts set forth herein.

14 On September 27, 2022, the Court entered the Order on Debtor's Ex-3. Parte Application for an Order Appointing Kurtzman Carson Consultants LLC as 15 16 Claims and Noticing Agent, Effective as of the Petition Date [Docket No. 54] 17 designating KCC as the claims and noticing agent, to assist with among other things, 18 (a) service of solicitation materials to the parties entitled to vote to accept or reject the 19 Plan, and (b) tabulation of votes with respect thereto. KCC has considerable 20 experience in soliciting and tabulating votes to accept or reject proposed chapter 11 21 plans.

### 22 A. Service and Transmittal of Solicitation Packages and Related Materials

4. Pursuant to the Order on Joint Motion of the Debtor and the Official
Committee of Unsecured Creditors for Entry of an Order (I) Granting Interim
Approval of the Adequacy of Disclosures in the Combined Joint Disclosure Statement
and Plan; (II) Approving Solicitation Packages and Procedures; (III) Approving the

Forms of Ballots; (IV) Setting Related Deadlines and (V) Granting Related Relief
 [Docket No. 1179] (the "Solicitation Order") entered on December 7, 2023, the Court
 established, among other things, certain Solicitation Procedures. KCC adhered to the
 Solicitation Procedures outlined in the foregoing documents and in the Ballots and
 Opt-Out Forms distributed to parties entitled to vote or opt out.

6 5. On December 11, 2023, KCC caused the Solicitation Packages, 7 including a Ballot and Opt-Out Form, to be served on all known Holders of Claims 8 entitled to vote on the Plan as of the November 28, 2023 Voting Record Date. Only 9 Holders of Claims in Class 3 (General Unsecured Claims) and Class 4 (DHCS Claims) 10 (collectively, the "Voting Classes") were entitled to vote to accept or reject the Plan. 11 No other Classes were entitled to vote on the Plan. In lieu of a Solicitation Packages, 12 Holders of Claims in Class 1 (Priority Non-Tax Claims) and Class 2 (Secured Claims) 13 (collectively, the "Non-Voting Classes") received the Non-Voting Combined Hearing 14 Notice and Opt-Out Form. A certificate of service evidencing the foregoing was filed 15 with the Court at Docket No. 1230.

- 16 6. On December 11, 2023, KCC posted links to the electronic versions of the Combined Plan, Combined Hearing Notice, Notice of Non-Voting Status, Opt-17 18 Out Form, and Plan Supplement on the public access website at 19 www.kccllc.net/BorregoHealth.
- 20 **B. Tabulation Process**

7. KCC worked closely with the Debtor's counsel, Committee counsel, and
financial advisors to create a voting database reflecting the names and addresses of
Holders of Claims and Interests, the classification of Claims and Interests, and voting
amounts for the Voting Classes. KCC relied on the Debtor's Schedules of Assets and
Liabilities and the claims information reflected on the register of filed proofs of claim,
to identify and solicit Holders of Claims and Interests in the Voting and Non-Voting
Classes.

1 In accordance with the Solicitation Procedures, KCC reviewed, 8. 2 determined the validity of, and tabulated the Ballots submitted to Vote on the Plan. 3 Each Ballot submitted to KCC was date-stamped, scanned, assigned a Ballot number, 4 entered into KCC's voting database, and processed. To be included in the tabulation 5 results as valid, a Ballot must have been (a) properly completed pursuant to the 6 Solicitation Procedures, (b) executed by the relevant Holder entitled to vote on the 7 Solicited Plan (or such Holder's representative), (c) returned to KCC via an approved 8 method of delivery set forth in the Solicitation Procedures unless the delivery method 9 requirement was waived by the Debtor, and (d) received by KCC on or before the 10 Voting Deadline (*i.e.*, January 8, 2024 at 4:00 p.m., Pacific Time) which was 11 established by the Solicitation Order.

9. The final tabulation of votes cast by timely and properly completed
ballots received by KCC is attached hereto as <u>Exhibit A</u>. The detailed Ballot reports
for all Voting Classes are attached hereto as <u>Exhibit A-1</u> and <u>Exhibit A-2</u>.

15 C. Opt-Out Election

16 10. KCC reviewed and documented which Holders of Claims or Interests
17 returned the Opt-Out Form and elected to opt out of the Third-Party Releases. A report
18 of all Holders who elected to opt out is attached hereto as Exhibit B. For the avoidance
19 of doubt, this Certification does not certify the validity or enforceability of any opt20 out elections received, including those reported on Exhibit B, but rather is providing
21 these opt-out election results for reporting and informational purposes only.

### 22 D. Ballots & Opt-Out Forms That Were Not Counted

11. A report of any Ballots or Opt-Out Forms from parties in the Voting or
Non-Voting Classes, excluded from the final tabulation, and the reasons for exclusion
are attached hereto as <u>Exhibit C</u>.

12. To the best of my knowledge, information and belief, the foregoing
information concerning the distribution, submission, and tabulation of Ballots in
connection with the Plan is true.
