MOTION OF DEBTORS FOR ORDER (I) APPROVING FORM OF NOTICE TO CREDITORS REGARDING (A) SATISFACTION OF CERTAIN SCHEDULED CLAIMS, AND (B) REMOVAL OR REDUCTION, AS APPLICABLE, OF SATISFIED CLAIMS FROM DEBTORS' SCHEDULES OF ASSETS AND LIABILITIES AND CLAIMS REGISTER; AND (II) GRANTING RELATED RELIEF

Briggs & Stratton Corporation and its debtor affiliates in the above-captioned chapter 11 cases, as debtors and debtors in possession (collectively, the "**Debtors**"), respectfully represent as follows in support of this motion (the "**Motion**"):

#### **Background**

1. On July 20, 2020 (the "Petition Date"), the Debtors each commenced with this Court a voluntary case under title 11 of the United States Code (the "Bankruptcy Code"). The Debtors are authorized to continue to operate their business and manage their properties as debtors in possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code. On August 5, 2020, the United States Trustee appointed an official committee of unsecured creditors (the "Creditors' Committee") in these chapter 11 cases pursuant to section 1102 of the Bankruptcy Code. No trustee or examiner has been appointed in these chapter 11 cases. The Debtors' chapter 11 cases are being jointly administered for procedural purposes only pursuant to Rule 1015(b) of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules") and Rule



1015(b) of the Local Rules of Bankruptcy Procedure for the Eastern District of Missouri (the "Local Rules").

- 2. On September 15, 2020, the Bankruptcy Court entered an order<sup>1</sup> authorizing the sale of the Debtors' assets to Bucephalus Buyer, LLC (the "**Purchaser**") and the sale transaction closed on September 21, 2020.<sup>2</sup> On October 9, 2020, the Debtors filed the *Joint Chapter 11 Plan of Briggs & Stratton Corporation and Its Affiliated Debtors* [Docket No. 1066] (the "**Plan**") and the *Disclosure Statement for Joint Chapter 11 Plan of Briggs & Stratton Corporation and Its Affiliated Debtors* [Docket No. 1067] (the "**Disclosure Statement**").<sup>3</sup> The Debtors continue to honor their post-closing sale obligations, wind down their estates, and work on confirming their proposed Plan and otherwise concluding these chapter 11 cases.
- 3. Additional information regarding the Debtors' business and capital structure and the circumstances leading to the commencement of these chapter 11 cases is set forth in the *Declaration of Jeffrey Ficks, Financial Advisor of Briggs & Stratton Corporation, in Support of the Debtors' Chapter 11 Petitions and First Day Relief* [Docket No. 51] (the "**Ficks Declaration**").<sup>4</sup>

#### Jurisdiction

4. The Court has jurisdiction to consider this matter pursuant to 28 U.S.C. §§ 157 and 1334. This is a core proceeding pursuant to 28 U.S.C. § 157(b). Venue is proper before the Court pursuant to 28 U.S.C. §§ 1408 and 1409.

#### **Relief Requested**

5. By this Motion, the Debtors seek entry of an order (the "**Proposed Order**")<sup>5</sup> pursuant to Bankruptcy Rules 2002(m) and 9007, (i) approving (a) the form of notice (the "**Notice**") identifying certain claims, as defined by section 101(5) of the Bankruptcy Code, that have been fully satisfied (collectively, the "**Satisfied Claims**," and such claimants, the "**Satisfied Claimants**"), and (b) the removal and expungement, or reduction, of such Satisfied Claims from the Debtors' Schedules (as defined below) and official claims registers for each of the Debtors (collectively, the "**Claims Register**"), and (ii) granting related relief. Lists of the identified Satisfied Claims are attached to the Notice as **Schedules 1 and 2**.

#### **Claims Reconciliation Process**

- 6. On August 23, 2020, the Debtors filed their schedules of assets, liabilities, current income, expenditures, executory contracts, and unexpired leases and statements of financial affairs, as required by section 521 of the Bankruptcy Code [Docket Nos. 555–559] (collectively, the "Schedules").
- 7. On August 24, 2020, the Court entered an order [Docket No. 564] (the "Bar Date Order"), which, among other things, established (a) October 7, 2020 as the deadline for all non-governmental entities holding or wishing to assert a "claim" (as defined in section 101(5) of the Bankruptcy Code) against any of the Debtors that arose before the Petition Date to file a proof

of such claim in writing (the "General Bar Date"), and (b) January 19, 2021 as the deadline for all governmental entities holding or wishing to assert a "claim" against any of the Debtors that arose before the Petition Date to file a proof of such claim in writing.

- 8. As of the date hereof, approximately 2,500 proofs of claim (the "**Proofs of Claim**") have been filed against the Debtors. The Debtors and their advisors have been working diligently to review these Proofs of Claim.
- 9. On their Schedules, the Debtors identified amounts owed to specific creditors (the "Scheduled Claims," and together with the Proofs of Claim, the "Claims") as of the Petition Date and without accounting for authorized payments under various orders entered on or around the Petition Date on an interim and final basis (the "First Day Orders"). Based on their review to date, the Debtors have identified certain of the Scheduled Claims, for which no proof of claim was filed, as Satisfied Claims because they were paid either in full or in part pursuant to the First Day Orders or in connection with the assumption and assignment of contracts to the Purchaser.
- been satisfied in full (the "Fully Satisfied Claims") through (i) authorized payments made by the Debtors pursuant to a First Day Order or (ii) cure payments made in connection with a contract assumption and assignment; (b) will be removed and expunged from the Debtors' Schedules and Claims Register; and (c) will not be included among the Claims eligible to vote to accept or reject the Debtors' Plan or receive a distribution under the Debtors' Plan.

11. <u>Schedule 2</u> attached to the Motion identifies claims that (a) have been satisfied in part (the "**Partially Satisfied Claims**") through (i) authorized payments made by the Debtors pursuant to a First Day Order or (ii) cure payments made in connection with a contract assumption; and (b) will be reduced in amount and revised on the Debtors' Schedules and Claims Register to reflect the amount that remains unpaid.

#### **Proposed Form and Manner of Notice of Satisfied Claims**

- 12. The Debtors propose to notify the Satisfied Claimants of the status of their Satisfied Claims substantially in the form attached hereto as Exhibit A to the Motion.
- 13. Any Satisfied Claimant that wishes to dispute the Debtors' determination that its Satisfied Claim has been satisfied in full or in part must file a written response (the "Response") with the Bankruptcy Court (a) by registered users of the Bankruptcy Court's case filing system, electronically in accordance with the Bankruptcy Rules and the Local Rules and (b) by all other parties in interest, in writing with the United States Bankruptcy Court Clerk's Office, 111 S. 10th Street, 4th Floor, St. Louis, Missouri 63102. In addition, such Satisfied Claimant must serve its Response upon counsel to the Debtors, (a) Weil, Gotshal & Manges LLP, 767 Fifth Avenue, New York, New York 10153 (Attn: Eli Blechman, Esq. (eli.blechman@weil.com) and Janiel Myers, Esq. (janiel.myers@weil.com)) and (b) Carmody MacDonald P.C., 120 S. Central Avenue, Suite 1800, St. Louis, Missouri 63105 (Attn: Dormie Ko, Esq. (dko@carmodymacdonald.com)), so that the Response is received no later than 4:00 p.m. (Central Time) on the date that is twenty-one (21) days from service of the Notice (the "Response Deadline").
- 14. All Responses filed by a Satisfied Claimant must contain, at a minimum, the following information:

- a caption setting forth the name of the Court, the case number, and the title of the Notice;
- the name of the responding party and description of the basis for the amount of the Satisfied Claim that the Satisfied Claimant is contesting has not been satisfied, if applicable;
- the specific factual and legal bases and all documentation or other evidence upon which the Satisfied Claimant opposes the Notice;
- the address(es) to which the Debtors must return any reply to the Response, if different from that presented in the Satisfied Claim; and
- the name, address, and telephone number of the person (which may be the Satisfied Claimant or his/her/its legal representative) possessing ultimate authority to communicate with respect to the Satisfied Claim or Response to the Notice on behalf of the responding party.
- 15. Upon the Debtors' receipt of a Response, the Debtors will determine whether there is a basis upon which to sustain the Satisfied Claimant's assertion that its Satisfied Claim has not in fact been satisfied. In the event the parties are unable to reach a resolution, the Debtors may remove the disputed Satisfied Claim from the respective schedule of Satisfied Claims attached to the Notice, or the Debtors or the Plan Administrator (as applicable) may seek relief from the Court to resolve the dispute at a hearing following not less than 21 days' notice to the respondent. The Debtors will file amended schedules of Satisfied Claims to reflect the removal of any disputed Satisfied Claim. The Debtors reserve the right to contest any disputed Satisfied Claim that is removed from either schedule of Satisfied Claims as attached to the Notice in the claims reconciliation process.
- 16. If a Satisfied Claimant fails to file and serve a timely Response by the Response Deadline, the Debtors' claims and noticing agent, Kurtzman Carson Consultants LLC ("KCC") is authorized, without further notice to any party (including the Satisfied Claimant) or further order of this Court, to treat such Satisfied Claim as fully or partially satisfied on the Claims Register.

#### **Relief Requested Should Be Granted**

### 1. The Court Should Approve the Form and Manner of Debtors' Notice of Satisfied Claims

- 17. Bankruptcy Rule 2002(m) provides that "[t]he court may from time to time enter orders designating the matters in respect to which, the entity to whom, and the form and manner in which notices shall be sent except as otherwise provided by these rules." Further, the Bankruptcy Rules provide that "[w]hen notice is to be given under these rules, the court shall designate, if not otherwise specified herein, the time within which, the entities to whom, and the form and manner in which the notice shall be given." Fed. R. Bankr. P. 9007.
- 18. Here, the Debtors request that the Court (a) approve the form and manner of the Notice and (b) authorize the Debtors' to revise the Claims Register to reflect the removal and expungement or reduction in amount (as applicable) of the Satisfied Claims. As described above, the Notice (a) identifies Claims which have been satisfied in part or in full and the method (i.e., through authorized payments made by the Debtors pursuant to a First Day Order or cure payments made in connection with a contract assumption and assignment) and date of satisfaction; (b) provides notice to Satisfied Claimants that Fully Satisfied Claims will be removed from the Debtors' Schedules and Claims Register, expunged, and not included among the Claims eligible to vote to accept or reject the Debtors' Plan; (c) provides notice to Satisfied Claimants that Partially Satisfied Claims will be reduced in amount and revised on the Claims Register to reflect the amount that remains unpaid; and (d) provides Satisfied Claimants with twenty-one (21) days, from the date of service of the Notice, to object or challenge the designation of its Claim as satisfied.
- 19. Accordingly, the Court should (a) approve the Debtors' form and manner of notice identifying Satisfied Claims, removing and expunging Fully Satisfied Claims from the Claims Register, and reducing the amount of Partially Satisfied Claims to reflect the amounts that

remain unpaid, and (b) authorize the Debtors to revise the Claims Register to reflect the removal and expungement or reduction in amount (as applicable) of the Satisfied Claims.

#### **Reservation of Rights**

20. Nothing contained herein is intended to be or shall be deemed as (i) an admission as to the validity of any claim against the Debtors, (ii) a waiver or limitation of the Debtors' or any party in interest's rights to dispute the amount of, basis for, or validity of any claim, (iii) a waiver of the Debtors' rights under the Bankruptcy Code or any other applicable nonbankruptcy law, (iv) an agreement or obligation to pay any claims, (v) a waiver of any claims or causes of action which may exist against any creditor or interest holder, or (vi) an approval, assumption, adoption, or rejection of any agreement, contract, lease, program, or policy under section 365 of the Bankruptcy Code.

#### **Notice**

Trustee for the Eastern District of Missouri; (ii) the holders of the thirty (30) largest unsecured claims against the Debtors on a consolidated basis; (iii) Latham & Watkins LLP (Attn: Peter P. Knight, Esq. and Jonathan C. Gordon, Esq.), as counsel to JPMorgan Chase Bank, N.A., as the administrative agent and collateral agent under the ABL Credit Facility and DIP Facility; (iv) Pryor Cashman LLP (Attn: Seth H. Lieberman, Esq. and David W. Smith, Esq.), as counsel to Wilmington Trust, N.A., as successor indenture trustee under the Unsecured Notes; (v) the United States Attorney's Office for the Eastern District of Missouri; (vi) Brown Rudnick LLP (Attn: Osaka P. Lashko, Esq.), as counsel to the Creditors' Committee; (vii) any other party that has requested notice pursuant to Bankruptcy Rule 2002; and (viii) any other party entitled to notice pursuant to Local Rule 9013-3(E) (collectively, the "Notice Parties"). Notice of this Motion and any order entered hereon will be served in accordance with Local Rule 9013-3(E)(1).

### **No Previous Request**

22. No previous request for the relief sought herein has been made by the Debtors to this or any other court.

WHEREFORE, the Debtors respectfully request entry of the Proposed Order granting the relief requested herein and such other and further relief as the Court may deem just and appropriate.
