No later than **November 17, 2020**, the Court will send a Cisco WebEx invite to all parties who have either received prior Cisco WebEx invites or have contacted Judge Schermer’s Courtroom Deputy, Shontelle McCoy, directly to make an initial request to appear remotely. (Parties are not required to make a request to appear remotely for each hearing.)

When accessing the audio, participants must join Cisco WebEx first via a computer and join the call second (either through the Call-In option and enter an attendee ID or through the “Call me at” option.) All participants must mute their phone lines immediately after joining the call. Phones shall not be placed on “hold”.
