**NOTICE OF TRUSTEE FINAL REPORT, CONFIRMATION OF INTERIM  
DISTRIBUTIONS, DEADLINES TO OBJECT TO TRUSTEE'S FINAL REPORT AND  
APPLICATIONS FOR COMPENSATION, AND STATUS OF CASE**

I. Notice of Trustee Final Report

Pursuant to Federal Rule of Bankruptcy Procedure 2002, please take notice that Ronald F. Greenspan, the Chapter 7 Trustee (the "Trustee") of the above-styled estate ("Estate"), has filed a Final Report and the Trustee and the Trustee's professionals have filed final fee applications, which are summarized in the attached Summary of Trustee's Final Report and Applications for Compensation.

The Final Report and applications for compensation are also available for inspection at the Office of the Clerk at the following address: 450 Golden Gate Avenue, San Francisco, CA 94102. A hearing on the Trustee's Final Report and the applications for compensation will be held on July 7, 2017, at 9:30 a.m. in Courtroom 17 (the Honorable Dennis Montali, presiding) in the U.S. Bankruptcy Court located at 450 Golden Gate Avenue, 16th Floor, San Francisco, CA 94102.

II. Confirmation of Interim Distributions and Notice of Anticipated Final Distributions

Since 2004, the Trustee has made Interim Distributions to allowed priority and general unsecured claims. Through Interim Distributions, priority claims have been paid 100% of their allowed amount and general unsecured claims have been paid 47.33% of their allowed amount.<sup>1</sup> As detailed in the Final Report, the Trustee proposes to make a Final Distribution to holders of allowed general unsecured claims of an additional 4.70%, bringing total distributions to unsecured creditors to 52.03% of their allowed claim.

Note that the Final Distribution is an estimate and is subject to final Court approval. **Our records indicate that you have received and will receive the following:**

<sup>1</sup> Unsecured creditors who received less than 47.33% were creditors whose Interim Distribution checks were returned to the Trustee and/or never cashed. These creditors will receive a larger Final Distribution to include the uncashed portion of the Interim Distribution.

III. Notice of Deadlines and Procedures Regarding Objections to Trustee’s Final Report and Final Fee Applications

Any person wishing to object to any final fee application or to the Trustee’s Final Report must file a written opposition thereto not later than fourteen (14) days before the date designated for hearing and serve a copy of the opposition upon: (1) the Trustee, through his counsel, David Gould of David Gould, APC ([dgould@gglawllp.com](mailto:dgould@gglawllp.com)), and Steven J. Katzman and Anne A. Uyeda of Bienert, Miller & Katzman PLC ([skatzman@bmkattorneys.com](mailto:skatzman@bmkattorneys.com), [auyeda@bmkattorneys.com](mailto:auyeda@bmkattorneys.com)); (2) any party whose application is being challenged; and (3) the United States Trustee (the “UST”). Objections are waived if a party fails to file and serve a written objection pursuant to the requirements set forth above. If no objections are filed, the Court will act on the fee applications and the Trustee may pay the Final Distribution pursuant to Federal Rule of Bankruptcy Procedure 3009 without further order of the Court.

IV. Background and Status of Case

The filing of the Trustee’s Final Report represents the culmination of many years of considerable effort by the Estate’s professionals in this bankruptcy case (the “Brobeck Case”), which was initiated by an involuntary Chapter 7 petition (“Petition”) filed approximately seven months after Brobeck, Phleger & Harrison LLP (“Brobeck”) ceased operations and after negotiations between Brobeck’s Liquidation Committee and Brobeck’s largest creditors had broken down. At the time the Trustee assumed control of the Estate approximately ten months following Brobeck’s closure, nearly all of the most readily collectible receivables had already been liquidated and the Estate had no operating funds. Notwithstanding these significant obstacles, the Trustee successfully resolved all of the claims against the Estate, resulting in total allowed general unsecured claims of approximately \$74 million, successfully recovered over \$90,000,000, negotiated a reduction in and retirement of the Estate’s secured debt, has paid \$4,000,000 of priority unsecured claims in full (principally employee claims), and anticipates paying general unsecured creditors over 50% of their allowed claims. The Trustee has paid approximately \$67 million in Interim Distributions to secured and unsecured creditors and anticipates paying a total of approximately \$3.95 million in additional Final Distributions to general unsecured creditors.

The Trustee has been finished with the Estates' asset liquidation and claims resolution for nearly three years and has been diligently trying to close the Estate. To that end, the Trustee has met and conferred extensively with the UST regarding the Trustee's Final Report (the "TFR").

The Trustee has made quarterly (and in the later years annual) filings of the Form 2, which lists every expenditure of the Estate. A provision in the Handbook for Chapter 7 Trustees (the "Handbook") requires hard copies of all of the Estate's cleared checks and bank statements to be attached to the TFR so the UST can compare them to the disbursements reported by the Trustee. The Trustee, his financial advisors, and his accountants have expended considerable effort (not charged to the Estate) to gather and deliver to the UST all such checks and bank statements in the Trustee's possession and the possession of the Trustee's banks. To the extent the Trustee did not have physical possession of certain cancelled checks or bank statements, the Trustee provided to the UST information relating to the amount, payee, and purpose of such disbursements, which was compiled from the computer-generated check registers produced by the computerized program Quickbooks. The check registers, which the Trustee had also provided to the UST, were the basis for the preparation of the Form 2 reports which were submitted on a quarterly basis to the Court and UST in this matter. Each Form 2 Report was timely filed and corresponded to the check register which the Trustee provided to the UST. The monthly bank statements were reconciled by an independent CPA who balanced and verified the check registers against the bank statements.

Out of an abundance of caution and to ensure that any creditors who did not receive their interim distributions have an opportunity to notify the Trustee and the UST of the same, the UST has requested (and the Trustee concurred) that this Notice include the procedures by which a creditor can send an e-mail to independent third party KCC regarding non-receipt of payment. *See* page 2 of this Notice.
