Buyk Corp. (the "**Debtor**"), as debtor and debtor-in-possession in the above-captioned Chapter 11 case (the "**Chapter 11 Case**"), by and through its undersigned counsel, hereby files this motion (the "**Motion**") for entry of an order, substantially in the form attached hereto as **Exhibit A** (the "**Order**"), pursuant to 11 U.S.C. §§ 105(a) and 365(a), Rule 6006 of the Federal Rules of Bankruptcy Procedure (the "**Bankruptcy Rules**"), Rule 6006-1 of the Local Bankruptcy Rules for the Southern District of New York (the "**Local Rules**"), (i) approving the Debtor's rejection of the Rejected Contracts listed and described on the schedule attached to the Order as

Exhibit 1 (the "Rejected Contract Schedule"), effective as of the Rejection Effective Date identified in the Rejected Contract Schedule for each Rejected Contract; and (ii) authorizing the Debtor to reject certain executory contracts, which contracts are listed and described on the schedule attached to the Order as Exhibit 2 (the "Rejectable Contract Schedule" and the counterparties to both the Rejected Contracts and Rejectable Contracts, the "Contract Counterparties"), and respectfully represents as follows:

#### **JURISDICTION**

- 1. The United States Bankruptcy Court for the Southern District of New York (the "Court") has jurisdiction over this Motion pursuant to 28 U.S.C. §§ 157 and 1334 and the Amended Standing Order of Reference from the United States District Court for the Southern District of New York, dated January 31, 2012.
  - 2. Venue in the Court is proper pursuant to 28 U.S.C. §§ 1408 and 1409.
  - 3. This is a core proceeding under 28 U.S.C. § 157(b).
- 4. The statutory bases for the relief requested herein are sections 105(a) and 365(a) of the Bankruptcy Code, as supplemented by Bankruptcy Rule 6006 and Local Rule 6006-1(a).

#### **BACKGROUND**

- 5. On March 17, 2022, the Debtor filed a voluntary petition for relief under chapter 11 of title 11 of the United States Code (the "Bankruptcy Code").
- 6. The Debtor is authorized to continue to operate its business and manage its properties as debtor-in-possession pursuant to section 1107(a) and 1108 of the Bankruptcy Code.
- 7. Additional details regarding the Debtor and its assets, liabilities, and other operations are set forth in in detail in the *Affidavit of James Walker Pursuant to Local Bankruptcy Rule 1007-2 And In Support of First Day Motions and Applications* (Docket No. 9).

#### **RELIEF REQUESTED**

- 8. Pursuant to sections 105(a) and 365(a) of the Bankruptcy Code, Bankruptcy Rule 6006, and Local Rule 6006-1, the Debtor respectfully requests the Court (i) approve the Debtor's rejection of the Rejected Contracts identified on the Rejected Contract Schedule attached as Exhibit 1 to the Order (the "**Rejected Contracts**") and (ii) authority to reject those certain executory contracts listed in the Rejectable Contract Schedule<sup>2</sup> attached to the Order as Exhibit 2 (the "**Rejectable Contracts**").<sup>3</sup>
- 9. With respect to the Rejected Contracts, the Debtor has generally determined that the vast majority of its contracts confer no benefits to the Debtor's estate. The Court's approval of the Debtor's rejection of the Rejected Contracts *nunc pro tunc* to the dates identified in Exhibit 1 to the Order is necessary, appropriate, and in the best interest of the Debtor and its Estate as the Debtor seeks only to orderly liquidate its assets and is no longer operating.
- 10. The contracts listed in the Rejectable Contract Schedule generally constitute the discrete exceptions where the Debtor has determined that such contracts shall remain in force for some limited period post-petition, but for which it now seeks authorization of the Court to reject.<sup>4</sup>

Authority for the Debtor to reject these Rejectable Contracts is necessary, appropriate, and in the best interest of the Debtor and its estate.

#### THE CONTRACTS

11. The Debtor seeks approval of the rejection of the Rejected Contracts because the vast majority of Debtor's contracts are not necessary to the Debtor's liquidation efforts. Moreover, the Debtor seeks authority to reject the Rejectable Contracts because as Debtor's liquidation efforts proceed, the Rejectable Contracts will no longer be necessary to those efforts. Accordingly, the Debtor seeks: (a) approval to designate the Rejected Contracts as rejected effective as of a date (the "Rejection Effective Date") set forth in Schedule 1 to the Order, and (b) authority to designate any of the Rejectable Contracts for rejection as of a Rejection Effective Date set forth in in either (i) a notice (the "Notices of Rejection") filed by the Debtor with respect to each particular Rejectable Contract which the Debtor rejects, or (ii) an order of this Court following an objection to such a Notice of Rejection.<sup>5</sup>

#### **BASIS FOR RELIEF**

12. Section 365(a) of the Bankruptcy Code provides that a debtor-in-possession "subject to the court's approval, may assume or reject any executory contract or unexpired lease of the debtor." 11 U.S.C. § 365(a); *see also NLRB v. Bildisco & Bildisco*, 465 U.S. 513, 521 (1984); *In re Lavigne*, 114 F.3d 379, 386 (2d Cir. 1997). "The purpose behind allowing the assumption or rejection of executory contracts is to permit the trustee or debtor-in-possession to use valuable property of the estate and to 'renounce title to and abandon burdensome property." *In re Orion* 

such is necessary. If the Debtor decides that it is willing to assume or assume and assign a Rejectable Contract, it will seek appropriate relief from the Court to effectuate such assumption or assumption and assignment.

*Pictures Corp.*, 4 F.3d 1095, 1098 (2d Cir. 1993); *see also In re Ames Dept. Stores, Inc.*, 306 B.R. 43, 51-52 (Bankr. S.D.N.Y. 2004) ("The ability to reject provides the trustee or debtor-in-possession with the means to relieve the estate of the duty to perform on burdensome obligations at the expense of all of the estate's other creditors, and to avoid the incurrence of additional administrative expenses which lack a corresponding benefit to the estate."); *In re Child World, Inc.*, 142 B.R. 87, 89 (Bankr. S.D.N.Y 1992).

- 13. The standard applied to determine whether the rejection of an executory contract or unexpired lease should be authorized is the "business judgment" standard. *See COR Route 5 Co., LLC v. The Penn Traffic Co.* (*In re Penn Traffic Co.*), 524 F.3d 373, 383 (2d Cir. 2008); *In re Old Carco LLC*, 470 B.R. 688, 703 (S.D.N.Y. 2012).
- upon finding that a debtor has exercised its sound business judgment, approve the rejection under section 365(a) of the Bankruptcy Code. *See Bildisco*, 465 U.S. at 52 (recognizing the "business judgment standard used to authorize rejection of executory contracts); *Nostas Assocs. v. Costich* (*In re Klein Sleep Prods., Inc.*), 78 F.3d 18, 25 (2d Cir. 1996) (recognizing the "business judgment" standard used to approve rejection of executory contracts); *In re Minges*, 603 F.2d 38, 43 (2d Cir. 1979) (holding that the "business judgment" test is appropriate for determining when an executory contract can be rejected); *In re Balco Equities, Ltd., Inc.*, 323 B.R. 85, 98 (Bankr. S.D.N.Y. 2005) ("A court should defer to a debtor's decision that rejection of a contract would be advantageous.").
- 15. The "business judgment" standard is not a strict standard; it requires only a showing that either assumption or rejection of the executory contract or unexpired lease will benefit the debtor's estate. *See In re Balco Equities Ltd., Inc.*, 323 B.R. 85, 99 (Bankr. S.D.N.Y. 2005) ("In determining whether the debtor has employed reasonable business discretion, the court for the

most part must only determine that the rejection will likely benefit the estate.") (quoting *In re G Survivor Corp.*, 171 B.R. 755, 757 (Bankr. S.D.N.Y. 1994), aff'd 187 B.R. 111 (S.D.N.Y. 1995)); *In re Helm*, 335 B.R. 528, 538 (Bankr. S.D.N.Y. 1996) ("To meet the business judgment test, the debtor in possession must 'establish that rejection will benefit the estate.") (citation omitted). Further, under the business judgment standard "a debtor's decision to reject an executory contract must be summarily affirmed unless it is the product of 'bad faith, or whim or caprice." *In re Trans World Airlines, Inc.*, 261 B.R. 103, 121 (Bankr. D. Del. 2001) (citation omitted).

- 16. Section 105(a) provides additional authority to the Court to grant the relief requested herein. Section 105(a) of the Bankruptcy Code provides that the court "may issue any order, process, or judgment that is necessary or appropriate to carry out the provisions of this title." Section 105(a) allows the bankruptcy court to "craft flexible remedies that, while not expressly authorized by the [Bankruptcy] Code, effect the result the [Bankruptcy] Code was designed to obtain." *In re Combustion Eng'g, Inc.*, 391 F.3d 190, 235-36 (3d Cir. 2004) (citing *Official Comm. of Unsecured Creditors of Cybergenics Corp. ex rel. Cybergenics Corp. v. Chinery*, 330 F.3d 548, 568 (3d Cir. 2003)).
- 17. The Debtor is no longer operating and is in the process of liquidating its assets. The Rejected Contracts are no longer necessary or required for the Debtor's liquidation and represent liabilities to the estate. In the Debtor's business judgment, it would be detrimental to its estate for the Debtor to continue to perform under the Rejected Contracts.
- 18. The Rejectable Contracts are limited exceptions where continued performance has or may have had some value to the estate but, as the Debtor's liquidation efforts progress, are unlikely to be necessary or required for the Debtor's liquidation and will represent liabilities to the estate that the Debtor seeks to minimize via the filing of this Motion. Granting the Debtor authority

to reject the Rejectable Contracts at a later date will provide the Debtor and those Contract Counterparties additional time to negotiate regarding the treatment of each of those contracts.

- 19. Upon rejection, the Rejected Contracts shall no longer be necessary for, or beneficial to, the Debtor's business and create unnecessary and burdensome expenses for the Debtor's estate. Rejecting the Rejected Contracts will maximize the value of the Debtor's estate by ridding the Debtor of the burdens imposed by the Rejected Contracts. Absent rejection, the Rejected Contracts will impose obligations on the Debtor and its estate that constitute an unnecessary drain on the Debtor's resources. The Debtor has thus determined that rejection of the Rejected Contracts is in the best interests of its estate and creditors. Accordingly, to avoid incurring unnecessary administrative expense claims with respect to the Rejected Contracts, the Debtor seeks approval of its rejection of the Rejected Contracts on Exhibit 1 to the Order effective as of the dates listed therein. Moreover, with respect to the Rejectable Contracts, the Debtor seeks authority to reject the Rejectable Contracts set forth on Exhibit 2 to the Order, the Rejectable Contract Schedule.
- 20. The decision to reject the Rejected Contracts therefore satisfies the business judgment rule, as this rejection is necessary to reduce the administrative costs to the estate and maximize the return available to the Debtor's unsecured creditors. The Debtor respectfully represents that rejecting the Rejected Contracts is appropriate under the circumstances and reflects the Debtor's sound business judgment.
- 21. In view of the foregoing, the Debtor respectfully requests that the Court approve Debtor's rejection of the Rejected Contracts and grant it authority to reject the Rejectable Contracts, effective as of each contract's Rejection Effective Date, pursuant to sections 105(a) and 365(a) of the Bankruptcy Code in the manner requested herein.

#### **BANKRUPTCY RULE 6006 IS SATISFIED**

- Bankruptcy Rule 6006(a) provides that a "proceeding to assume, reject, or assign an executory contract or unexpired lease . . . is governed by Rule 9014." Fed. R. Bankr. P. 6006(a). In turn, Bankruptcy Rule 9014 states that "[i]n a contested matter . . . not otherwise governed by these rules, relief shall be requested by motion, and reasonable notice and opportunity for hearing shall be afforded the party against whom relief is sought." Fed. R. Bankr. P. 9014(a).
- 23. Bankruptcy Rule 6006(e) allows a debtor to consolidate, in a single motion, requests for the authority to reject multiple executory contracts or unexpired leases that are among different parties, subject to Bankruptcy Rule 6006(f). See Fed. R. Bankr. P. 6006(e). Bankruptcy Rule 6006(f) requires, in part, that such omnibus motion must: (i) "state in a conspicuous place that parties receiving the omnibus motion should locate their names and their contracts or leases listed in the motion"; (ii) "list parties alphabetically and identify the corresponding contract or lease"; (iii) "be numbered consecutively with other omnibus motions to assume, assign, or reject executory contracts or unexpired leases"; and (iv) "be limited to no more than 100 executory contracts or unexpired leases." Fed. R. Bankr. P. 6006(f).
- 24. Here, the Debtor has provided notice to the Contract Counterparties to the Rejected Contracts and Rejectable Contracts such that they can take appropriate action. Additionally, this Motion provides conspicuous notice that the parties receiving the Motion should locate their names and agreements, includes the Contract Counterparties to both the Rejected Contracts and Rejectable Contracts in alphabetical order, and identifies the contracts rejected or to be rejected. This Motion and the notice provided to the Contract Counterparties and other parties in interest are thus sufficient under Bankruptcy Rule 6006. To the extent the Motion does not comply with Bankruptcy Rule 6006, the Debtor respectfully requests a waiver.

25. In view of the foregoing, the Debtor respectfully requests that the Court approve the Debtor's rejection of the Rejected Contracts and grant it authority to reject the Rejectable Contracts pursuant to sections 105(a) and 365(a) of the Bankruptcy Code and Bankruptcy Rule 6006 in the manner requested herein.

#### **MOTION PRACTICE**

26. This Motion includes citations to the applicable rules and statutory authorities upon which the relief requested herein is predicated and a discussion of their application to this Motion. Accordingly, the Debtor submits that this Motion satisfies Local Rule 9013-1(a).

#### **RESERVATION OF RIGHTS**

27. Nothing contained in this Motion or any actions taken by the Debtor pursuant to relief granted is intended or should be construed as: (i) an admission as to the validity of any claim against the Debtor; (ii) a waiver or limitation of the Debtor's rights under the Bankruptcy Code or any other applicable law; (iii) a waiver by the Debtor of its right to dispute the amount of, basis for, or validity of any claim, including, but not limited to, any rejection damages claim; (iv) a waiver by the Debtor of its right to dispute or assert that any of the Rejected Contracts or Rejectable Contracts were breached by counterparties thereto and/or terminated prior to the entry of the Order; (v) a waiver or limitation of the Debtor's right to assert at a later date that the Rejected Contracts or Rejectable Contracts are not executory contracts or unexpired leases; or (vi) a concession or evidence that any of the Rejected Contracts or Rejectable Contracts have not expired, been terminated, or otherwise currently is not in full force and effect.

#### **NOTICE**

28. The Debtor has caused a copy of this Motion to be served upon (i) the Office of the

U.S. Trustee; (ii) the holders of the 20 largest unsecured claims against the Debtor; (iii) Legalist

DIP Fund I, LLP, the Debtor's pre-petition lender; (iv) the counterparties to the Rejected Contracts

and Rejectable Contracts, and (v) those persons who have formally appeared in the Chapter 11

Case and requested service pursuant to Bankruptcy Rule 2002; and (vi) all applicable government

agencies to the extent required by the Bankruptcy Rules and the Local Rules. The Debtor submits

that, in view of the facts and circumstances, such notice is sufficient and no other or further notice

need be provided.

NO PRIOR REQUEST

29. No prior request for the relief sought in this Motion has been made to this or any

other court.

WHEREFORE, the Debtor respectfully requests entry of an order in substantially the

form attached hereto as **Exhibit A** (i) approving the Debtor's rejection of the Rejected Contracts

described on Exhibit 1 to the Order effective as of the Rejection Effective Dates described therein;

(ii) authorizing the Debtor to reject the Rejectable Contracts described on the Rejectable Contract

Schedule described on Exhibit 2 to the Order; and (iii) granting such other and further relief as the

Court deems just and proper.

- 2. Pursuant to section 365 of the Bankruptcy Code and Bankruptcy Rule 6006, the Debtor's rejection of the Rejected Contracts listed and described on the schedule attached to this Order as Exhibit 1, effective as of the Rejection Effective Date for each Rejected Contract, is approved.
- 3. Pursuant to section 365 of the Bankruptcy Code and Bankruptcy Rule 6006, and in order to provide the Debtor and non-Debtor counterparties additional time to negotiate regarding the treatment of each of the contracts listed in the Rejectable Contracts Schedule attached to this Order as Exhibit 2, the Debtor shall be authorized to reject any of the contracts listed and described on said exhibit by filing a notice of said rejection with the Court upon notice to the affected non-Debtor counterparty. Said notice shall set forth the proposed effective date of said rejection and may contain other terms relating to such rejection as may be agreed to by the parties to the Rejected Contract. If an impacted non-Debtor counterparty disagrees with the effective date of the rejection or the other terms specified in the notice, it may file an objection within seven (7) days of receiving such notice. Any timely filed objection regarding the effective date of the rejection or other terms specified in, or omitted from, the notice shall be resolved by the Court upon request for a hearing. Failure to object within the seven-day period specified for the filing of an objection pursuant to this paragraph 3 shall constitute a waiver of the right to later object to the proposed effective date of the rejection or the other terms specified in the notice. An impacted non-Debtor counterparty will also be deemed to have waived its right to object to a notice filed pursuant to this paragraph if the non-Debtor counterparty or its attorney has countersigned the notice filed by the Debtor.

Each non-Debtor counterparty to a Rejected Contract shall have until the latter of

(a) the general claims bar deadline, and (b) thirty (30) days following (i) if unopposed, the date of

notice of rejection of the Rejected Contract; or (ii) entry of an order adjudicating the Rejected

Contract, to file a claim for any damages arising out of or related to a Rejected Contract.

5. The rejection of a Rejected Contract under this Order shall not be deemed as a

finding of the Court or an admission by the Debtor that Rejected Contract governed by this Order

is valid, unexpired, or enforceable, or that the non-Debtor counterparty under any such Rejected

Contract is entitled to any damages as a result of entry of either this Order or a subsequent order

of this Court adjudicating the terms of a contract rejection with respect to a Rejected Contract.

6. The Debtor is authorized to take any additional actions as are necessary or

appropriate to implement and effectuate the rejections approved hereby.

7. The Motion satisfies Bankruptcy Rules 2002, 6006 and 9014.

8. This Court shall retain jurisdiction to hear and determine all matters arising from

or related to this Order.
