Genesis Credit Partners LLC ("GCP"), Financial Advisor to the Official Committee of Unsecured Creditors (the "Committee") of the above-captioned debtors and debtors in possession (the "Debtors"), hereby submits this application (this "Fee Application") for monthly allowance of compensation for professional services rendered by GCP to the Committee for the period from March 21, 2024 through and including March 31, 2024 (the "Fee Application Period") and reimbursement of actual and necessary expenses incurred by GCP during the Fee Application Period, pursuant to sections 330 and 331 of title 11 of the United States Code (the "Bankruptcy Code"), Rule 2016 of the Federal Rules of Bankruptcy Procedure, Rule 2016-2 of the Local Rules of Bankruptcy Practice and Procedure of the United States Bankruptcy Court for the District of Delaware (the "Local Rules"), the United States Trustee's Guidelines for Reviewing

Applications for Compensation and Reimbursement of Expenses filed under 11 U.S.C. § 330 by Attorneys in Larger Chapter 11 Cases, effective November 1, 2013 and the Order Pursuant to 11 U.S.C. §§ 105(a), 330, and 331 and Fed. R. Bankr. P. 2016 (I) Establishing Procedures for Interim Compensation and Reimbursement of Expenses of Professionals, and (II) Granting Related Relief dated March 5, 2024 [Docket No. 243] (the "Interim Compensation Procedures Order").²

Pursuant to Local Rule 2016-2, this Application is supported by the Certification of Edward Kim, which is attached hereto. In support of this Fee Application, GCP respectfully represents as follows:

JURISDICTION

1. The Court has jurisdiction to consider this matter pursuant to 28 U.S.C. § 1334 and the *Amended Standing Order of Reference from the United States District Court for the District of Delaware*, dated February 29, 2012. This matter is a core proceeding within the meaning of 28 U.S.C. § 157(b). Venue is proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409.

BACKGROUND

- 2. Commencing on February 4, 2024 (the "<u>Petition Date</u>") and continuing on February 5, 2024, each of the Debtors filed a voluntary petition for relief under chapter 11 of the Bankruptcy Code with this Court. The Debtors continue to operate their business and manage their properties as debtors in possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code. No trustee or examiner has been appointed in the Chapter 11 Cases.
- 3. On February 21, 2024, the Office of the United States Trustee for the District of Delaware (the "<u>U.S. Trustee</u>") filed the *Notice of Appointment of Committee of Unsecured*

Creditors [Docket No. 154] appointing the following members to the Committee: CD Support LLC, Second Wave Delivery Systems, LLC, Navina Technologies Ltd., 2380-90 NW 7 Street LLC, and 107 Commercial Property LLC.

4. On February 22, 2024, the Committee selected Paul Hastings LLP to serve as its lead counsel, subject to this Court's approval. The Committee also selected (a) Cole Schotz P.C. ("Cole Schotz") to serve as its Delaware counsel and (b) Force Ten Partners LLC to serve as its financial advisor, in each case, subject to this Court's approval. Effective as of March 21, 2024, the Committee approved the substitution of financial advisor of GCP, a newly formed advisory firm which is comprised of the same financial advisory team at Force Ten Partners, LLC which was initially advising the Committee.

INTERIM COMPENSATION PROCEDURES ORDER

- 5. The Court entered the Interim Compensation Procedures Order on March 5, 2024.
 The Interim Compensation Procedures Order sets forth the procedures for interim compensation and reimbursement of expenses for all Professionals in the Chapter 11 Cases.
- 6. In particular, the Interim Compensation Procedures Order provides that Professionals may file and serve a Monthly Fee Application on or after the last day of each calendar month following the month for which compensation is sought, or as soon as practicable thereafter, for interim approval and allowance of compensation for services rendered and reimbursement of services incurred during any preceding month or months. Parties in interest will have 20 days after the service of a Monthly Fee Application to object to the requested compensation for services rendered and reimbursement of expenses incurred. If there are no objections to such Monthly Fee Application filed within 20 days after the service of the Monthly Fee Application, the Professional may file a certificate of no objection (the "Certificate of No Objection") with the Court.

7. Upon the filing of a Certificate of No Objection, the Debtors are authorized and directed to pay such Professional 80% of the fees and 100% of the expenses requested in such Monthly Fee Application. If a partial objection to the Monthly Fee Application is filed, then the Debtors are authorized to pay 80% of the fees and 100% of the expenses not subject to an objection.

NATURE AND EXTENT OF FINANCIAL SERVICES PROVIDED

- 8. As financial advisor to the Committee, GCP has provided extensive financial advisory services to the Committee in the Chapter 11 Cases. The total number of hours expended by GCP professionals and paraprofessionals in performing professional services for the Committee during the Fee Application Period was 365.4 hours at a blended billing rate of \$651.52 per hour.
- 9. GCP believes the foregoing rates are the market rates that financial advisory firms charge clients for such fees. In addition, GCP worked closely with the Committee's co-counsels, Paul Hastings LLP and Cole Schotz P.C., to ensure that there was no duplication of services and that all matters were appropriately and diligently handled for the Committee in a timely and efficient manner.
- 10. Attached hereto as **Exhibit A** are the detailed time records of GCP professionals for services rendered during the Fee Application Period, organized by matter, including a breakdown of disbursements incurred by GCP during the Fee Application Period (the "<u>Invoice</u>"). The Invoice identifies each individual GCP professional or staff person who provided services to the Committee during the relevant time period as well as the following: (1) his or her individual billing rate; (2) the total number of hours expended by that person; and (3) the total fees incurred. These entries provide detailed descriptions of GCP's services during the Fee Application Period.
- 11. GCP established task codes and project categories (the "<u>Project Categories</u>") for work performed by GCP's professionals in the Chapter 11 Cases. GCP attempted to place the

services provided in the Project Category that best relates to such services. However, because certain services may relate to one or more Project Categories, services pertaining to one Project Category may in fact be included in another Project Category. During the Fee Application Period, GCP rendered services to the Committee for each of the Project Categories that were both necessary and beneficial. GCP's professionals performed work and billed time for each category as detailed in **Exhibit A**.

ACTUAL AND NECESSARY COSTS AND EXPENSES INCURRED

12. During the Fee Application Period, GCP incurred reasonable and necessary disbursements in the amount of \$4,120.09 in the performance of its duties to the Committee during the Fee Application Period and respectfully requests reimbursement of such amount.

RELIEF REQUESTED

- 13. During the Fee Application Period, GCP incurred actual, reasonable, and necessary fees in the amount of \$238,065.00. For the same period, GCP incurred actual, reasonable, and necessary expenses totaling \$4,120.09. Pursuant to the Interim Compensation Procedures Order, GCP seeks payment of \$194,572.09, representing 80% of GCP's fees for services rendered, and reimbursement of 100% of expenses. As of the date of this Application, GCP has received no payment for the fees and expenses requested herein.
- 14. No agreement or understanding exists between GCP and any other person for the sharing of compensation received or to be received for services rendered in or in connection with the Chapter 11 Cases.
- 15. The undersigned has reviewed the requirements of Local Rule 2016-2 and certifies to the best of his information, knowledge, and belief that this Application complies with that Local Rule.

NOTICE

16. A copy of this Fee Application has been served on each of the Notice Parties (as defined in the Interim Compensation Procedures Order).

CONCLUSION

WHEREFORE, GCP respectfully requests that this Court: (a) allow GCP interim compensation in the amount of \$190,452.00 for actual, reasonable, and necessary professional services rendered on behalf of the Committee during the Fee Application Period; (b) authorize and direct the Debtors to pay to GCP the amount of \$194,572.09, which is equal to the sum of 80% of such amount and 100% reimbursement of expenses; and (c) grant such other and further relief as is just and proper.
