DECLARATION OF ADAM GORMAN REGARDING THE SOLICITATION AND TABULATION OF VOTES ON THE JOINT PREPACKAGED CHAPTER 11 PLAN OF REORGANIZATION OF CARESTREAM HEALTH, INC., AND ITS DEBTOR AFFILIATES

- I, Adam Gorman, depose and say under the penalty of perjury:
- 1. I am a Director of Corporate Restructuring Services employed by Kurtzman Carson Consultants LLC ("KCC"), located at 222 North Pacific Coast Highway, Suite 300, El Segundo, California 90245. I am over the age of 18 and not a party to this action.
- 2. I submit this declaration with respect to the solicitation of votes and the tabulation of ballots cast on the *Joint Prepackaged Chapter 11 Plan of Reorganization of Carestream Health, Inc., and Its Debtor Affiliates* [Docket No. 14] (as amended, supplemented, or otherwise modified from time to time, the "Plan").²
- 3. Prior to the commencement of these chapter 11 cases, Carestream Health, Inc. and its affiliated debtors and debtors in possession (collectively, the "<u>Debtors</u>") engaged KCC as their

claims and noticing (the "Claims and Noticing Agent") to assist with, among other things, (a) serving solicitation materials to the parties entitled to vote to accept or reject the Plan and (b) tabulating votes cast with respect thereto. KCC and its employees have considerable experience in soliciting and tabulating votes to accept or reject proposed chapter 11 plans. On August 23, 2022, the Debtors filed the Debtors' Application for Authorization to Employ and Retain Kurtzman Carson Consultants LLC as Claims and Noticing Agent Effective as of August 23, 2022 [Docket No. 4].

4. Except as otherwise noted, all facts set forth herein are based on my personal knowledge, knowledge that I acquired from individuals under my supervision, and/or my review of the relevant documents. I am authorized to submit this declaration (this "Voting Report") on behalf of KCC. If I were called to testify, I would testify competently as to the facts set forth herein.

A. Service and Transmittal of Solicitation Packages and Related Information.

- 5. KCC worked with the Debtors and their counsel to solicit votes to accept or reject the Plan and to tabulate the ballots of creditors voting to accept or reject the Plan.
- 6. On August 21, 2022, KCC caused to be distributed via email: (a) with respect to Holders of Claims in each of the Voting Classes (as defined herein) as of the Voting Record Date (as defined herein), (i) the Plan, (ii) the *Disclosure Statement for the Joint Prepackaged Chapter 11 Plan of Reorganization of Carestream Health, Inc., and Its Debtor Affiliates* [Docket No. 15] (as amended, supplemented, or otherwise modified from time to time, the "<u>Disclosure Statement</u>"), (iii) a solicitation cover letter (the "<u>Solicitation Cover Letter</u>"), and (iv) the applicable Class 3 or Class 4 ballot (as applicable, the "<u>Ballot</u>") to indicate such Holder's election to accept or reject the plan and to opt out of the Plan's third-party release provision, as applicable; (b) with respect to

Holders of First Lien Revolving Claims in Class 3, the form to elect to participate in the ABL Roll Option (the "ABL Roll Election Form")³; and (c) with respect to Holders of Second Lien Term Loan Claims in Class 4 as of the Rights Offering Record Date (as defined herein), (i) the procedures and instructions for participation in the Rights Offering (the "Rights Offering Procedures") and (ii) the form for participation in the Rights Offering⁴ (together with the Plan, the Disclosure Statement, the Solicitation Cover Letter, the Ballots, the ABL Roll Election Form, and the Rights Offering Procedures, as appliable to each Holder, the "Solicitation Packages").

- 7. The Solicitation Packages were distributed in accordance with the solicitation procedures (the "Solicitation Procedures") described in the Debtors' Motion for Entry of an Order (I) Scheduling a Combined Disclosure Statement Approval and Plan Confirmation Hearing, (II) Approving Related Dates, Deadlines, Notices, and Procedures, (III) Approving the Solicitation Procedures and Related Dates, Deadlines, and Notices, (IV) Approving the Rights Offering Procedures and Related Dates, Deadlines, and Notices, and (V) Conditionally Waiving the Requirements that (A) the U.S. Trustee Convene a Meeting of Creditors and (B) the Debtors File Schedules of Assets and Liabilities, Statements of Financial Affairs, and Rule 2015.3 Financial Reports [Docket No. 20] (the "Scheduling Motion").
- 8. A certificate evidencing the service of the Solicitation Packages was filed with the Court on August 23, 2022 [Docket No. 39].

As provided in the Scheduling Motion and the ABL Roll Election Form, the deadline for Holders of First Lien Revolving Claims in Class 3 to submit an ABL Roll Election Form is August 26, 2022, at 5:00 p.m. (prevailing Eastern Time).

B. The Tabulation Process

- 9. Pursuant to the Plan, Holders of Claims in Class 3 (First Lien Claims) and Class 4 (Second Lien Term Loan Claims) (collectively, the "<u>Voting Classes</u>") were entitled to vote to accept or reject the Plan. No other classes were entitled to vote on the Plan. The Debtors established August 15, 2022 (the "<u>Voting Record Date</u>"), as the date as of which a Holder of record of a Claim in the Voting Classes must have held such Claim to cast a vote to accept or reject the Plan.
- 10. The Disclosure Statement and the Ballot delivered to Holders of Claims in the Voting Classes instructed such Holders to follow the instructions contained in the Ballot (and described in the Disclosure Statement). The Ballot instructed the Holders of Claims in the Voting Class to complete and submit their Ballots to cast their votes to accept or reject the Plan. Holders of Claims in the Voting Classes were instructed to submit their Ballot to KCC via email to CarestreamBallots@kccllc.com.
- as the deadline for receiving Ballots to accept or reject the Plan (the "<u>Voting Deadline</u>"). Pursuant to the Solicitation Procedures, KCC received and tabulated Ballots as follows: (a) each Ballot returned by email was reviewed; and (b) all Ballots received on or before the Voting Deadline (unless the Debtors directed KCC to count a Ballot received after the Voting Deadline) were tabulated in accordance with the tabulation rules outlined in the Solicitation Procedures.
- 12. Set forth below is a summary of the voting results with respect to the Voting Classes tabulated on a consolidated basis:

- 13. The final tabulation of votes cast by timely (unless the Debtors directed KCC to count a Ballot received after the Voting Deadline) and properly completed Ballots received by KCC is attached hereto as **Exhibit A**. The detailed Ballot reports for Class 3 and Class 4 are attached hereto as **Exhibits A-1** and **A-2**, respectively.
- 14. In addition, in accordance with the Solicitation Procedures, KCC reviewed and tabulated the elections recorded on the Ballots from Holders of Claims in the Voting Classes to opt out of the Plan's third-party release. As set forth on **Exhibit B**, KCC did not receive any Ballots from Holders that checked the opt-out box on their Ballots.

C. Ballots That Were Not Counted.

15. As set forth on **Exhibit C**, KCC did not receive any Ballots that were not included in the tabulation above because they did not satisfy the requirements for a valid Ballot as set forth in the Scheduling Motion for the reasons described therein.

D. Conclusion.

16. To the best of my knowledge, information, and belief, the foregoing information concerning the distribution, submission, and tabulation of Ballots in connection with the Plan is
