2. Hunton is allowed final compensation in the amount of \$483,893.50 and reimbursement of expenses in the amount of \$13,987.11 for the Application Period as requested in the Application.

3. WTM is authorized and directed to disburse to Hunton payment in the amount of the difference between the allowed amounts and any actual interim payments previously received by Hunton for fees and expenses incurred during the Application Period.

4. WTM is authorized and empowered to take such actions as may be necessary and appropriate to implement the terms of this Order.

5. This Court shall retain jurisdiction with respect to all matters relating to the interpretation or implementation of this Order.

6. This Order shall be effective immediately upon entry.
