FINAL DECREE IN THE CHAPTER 11 CASE OF WTM I COMPANY

Upon the motion (the “Motion”)² of WTM I Company (“WTM”) for entry of a final decree, (a) approving the Final Account; (b) pursuant to section 105(a) of title 11 of the United States Code, 11 U.S.C. §§ 101–1532 (as amended, the “Bankruptcy Code”) and Rules 1005 and 2002 of the Federal Rules of Bankruptcy Procedure (the “Bankruptcy Rules”), changing the caption of the Remaining Debtors’ jointly administered cases; (c) relieving the Plan Administrator and his agents, professionals, and employees, of their duties; and (d) pursuant to sections 105 and 350 of the Bankruptcy Code and Bankruptcy Rule 3022, closing WTM’s chapter 11 case, the Court finds that: (i) the estate of WTM has been fully administered; (ii) it has jurisdiction over the matters raised in the Motion pursuant to 28 U.S.C. § 1334(b); (iii) this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2); (iv) the relief requested in the Motion is in the best interest of WTM, its estate, and its creditors; (v) proper and adequate notice of the Motion and the hearing thereon has been

given and no other or further notice is necessary; and (vi) upon the record herein, after due deliberation thereon, good and sufficient cause exists for the granting of the relief set forth herein.

Therefore,

IT IS HEREBY ORDERED THAT:

1. The Motion is **GRANTED**.
2. The Final Account is approved.
3. WTM; the Plan Administrator; and their agents, professionals, and employees shall be relieved of any further duties as of the filing of the Final Distribution Certification.
4. Pursuant to sections 105(a) and 350(a), the chapter 11 case of WTM, Case No. 08-36649-KLP, shall be and hereby is closed effective as of the date of the entry of this final decree.
5. The Clerk of the Court shall enter this final decree on WTM's docket and thereafter such docket shall be marked as "Closed."
6. The caption of the Remaining Debtors' jointly administered chases shall be modified to reflect the closing of WTM's case.

7. The caption of the Remaining Debtors' jointly administered cases shall read as follows:
