5 completed on the movant, no later than fourteen (14) days preceding the hearing date for
6 the motion. The opposition must set forth all relevant facts and any relevant legal
7 authority. An opposition must be supported by affidavits or declarations that conform to
8 the provisions of subsection (c) of this rule.

9 If you object to the relief requested, you *must* file a **WRITTEN** response to this
10 pleading with the court. You *must* also serve your written response on the person
11 who sent you this notice.

12 If you do not file a written response with the court, or if you do not serve your written
13 response on the person who sent you this notice, then:

- 14 • The court may *refuse to allow you to speak* at the scheduled hearing; and
- 15 • The court may *rule against you* without formally calling the matter at the
16 hearing.

17 **PLEASE TAKE FURTHER NOTICE** that this hearing may be continued from time to
18 time without further notice except for the announcement of any adjourned dates and times at the
19 above-noticed hearing or any adjournment thereof, and the court may approve modifications at the
20 hearing or any continued hearing.
