The cost of the tree removal and estimates for the roof, gutters and chimney repair is five thousand, four hundred fifty dollars (\$5,450.00). The other documents I submitted were to support and or verify the citys' ownership.





The written objection must be filed and received by Corporation Counsel by February 6, 2013. 
