**INTRODUCTION**

The Cabarets' pending appeal before the Sixth Circuit will determine the amount of damages subject to the approved, operative Plan of Adjustment and does not seek to violate any order of this Court. It only seeks to determine the liquidated amount subject to the Plan of Adjustment. City of Detroit's Motion for the Entry of an Order Enforcing the Plan of Adjustment Injunction Against H.D.V. Greektown, LLC, 415 East Congress, LLC, and K&P, Incorporated [Doc. 12852].

In addition, the Court should reconsider its Order [Doc. 12863] due to circumstances that prevented counsel for the Cabarets from submitting a timely response and because the absence of the response produced an order which is inequitable and contrary to law.



## **STATEMENT OF FACTS**

### *The Lawsuit*

Cabarets' lawsuit, the City of Detroit (H.D.V. Greektown, LLC v. City of Detroit, 2:06-cv-11282-AJT-RSW (the "Lawsuit")), was originally filed on March 28, 2016. [**Exhibit 6-1**, Lawsuit Docket Report, p. 5, Entry No. 1]. Following a settlement of the substance of the Lawsuit by way of a consent decree on August 23, 2011 [**Ex. 6-1**, p. 18, Entry No. 145], Cabarets filed a motion for attorney fees and costs on October 4, 2011 [Id., Entry No. 148]. Nearly two years later, on May 23, 2013, the magistrate judge entered a report and recommendation on the motion and Cabarets objected on June 5, 2013.

During the pendency of those objections, on August 20, 2013, the City filed a "Notice of Suggestion of Pendency of Bankruptcy Case and Application of the Automatic Stay" [**Exhibit 6-2**]. On August 23, 2013, the district court ordered a stay subject to the completion of the bankruptcy proceedings. [**Ex. 6-1**, Lawsuit Docket Report, p. 21 (Text-Only Order)].

Thereafter, on May 31, 2015, the district court entered an order adopting the report and recommendation. [**Exhibit 6-3**]. That order noted that "[i]n December, 2014, the municipal Defendant emerged from bankruptcy; accordingly, the Court will now issue its ruling . . . ." [Id.]. Cabarets appealed to the Sixth Circuit and

received a favorable opinion and mandate. See H.D.V. – Greentown, LLC v. City of Detroit, 660 Fed. Appx. 375 (6th Cir. Aug. 23, 2016).

Following the remand, the Cabarets renewed their request for attorney fees and costs on September 20, 2016. [**Ex. 6-1**, Lawsuit Docket Report, p. 21, Entry No. 174]. The matter was referred to the magistrate, who entered an order granting the motion in part, and denying in part. [Id. at p. 22, Entry No. 179]. Cabarets objected and the court entered an order adopting in part the report and recommendation. [Id. at Entry No. 182]. The Cabarets then appealed to the Sixth Circuit (the “Appeal” being H.D.V. – Greektown, LLC v. City of Detroit, Sixth Circuit Case No 18-1203), which is now the subject of Detroit’s Motion.

At no time since Cabarets’ filing of their renewed motion for attorney fees, after the remand (September 20, 2016) and until the present Motion, did the City contend that Cabarets were enjoined from seeking an enhancement of attorney fees and costs under Perdue v. Kenny A. ex rel. Winn, 559 U.S. 542 (2010).

#### *The Motion to Reconsider*

The City’s Motion was filed on July 11, 2013 and received by counsel for the Cabarets on July 13, 2013. [**Exhibit 5**, Declaration of Matthew J. Hoffer, Esq. (“Hoffer Dec.”), ¶ 7]. Counsels for the Cabarets, Bradley J. Shafer and Matthew J. Hoffer were out-of-state at a conference from July 11, 2018 through July 17, 2018, where each served as a presenter. [Id. at ¶ 5]. Mr. Shafer traveled to San Diego the

following week for a mediation in a class action matter. [Id. at ¶ 6]. Mr. Hoffer concentrated his efforts on preparing and finalizing an opening brief in a matter before the Ninth Circuit, which was ultimately filed on July 31, 2018. [Id. at ¶ 8].

Nevertheless, Mr. Hoffer tasked a law clerk with verifying that no special admission was required to practice in bankruptcy court and to verify that a CM/ECF login and password were on file for Mr. Shafer for this Court. [Id. at ¶ 9] A response to the Motion was prepared for filing, but on Mr. Hoffer's attempt to file on behalf of Mr. Shafer, he was unable to login because the login information was invalid. [Id. at ¶ 10].

Mr. Hoffer contacted the City to request an extension to rectify the e-filing issue, which the City denied. Unable to request an extension electronically, Mr. Hoffer modified and physically signed the documents and overnighted them for filing with the Court. [Id. at ¶ 11]. The filing was rejected for failure to request leave to file in the traditional fashion, and a subsequent attempt to file was rejected for failure of the application to include a proposed order. [Id. at ¶ 12]. Upon receiving the Court's Order granting the Motion on August 9, 2018, Mr. Hoffer calculated the due date for reconsideration under Rule 9024-1, and began the process of becoming a registered e-filer with the Court. [Id. at ¶ 1].

## ARGUMENT

### **I. BECAUSE THE ISSUE RELATES TO DETERMINING THE LIQUIDATED AMOUNT SUBJECT TO THE PLAN OF ADJUSTMENT, OBJECTORS ARE NOT PRECLUDED FROM REQUESTING AN ENHANCEMENT OF ATTORNEY FEES.**

Cabarets are not asking the Sixth Circuit to violate or set aside the Plan of Adjustment approved by this Court. Rather, the Cabarets are asking the Sixth Circuit to determine whether a municipal bankruptcy is an “exceptional circumstance,” under the rubric of Perdue v. Kenny A. ex rel. Winn, 559 U.S. 542 (2010). Any award of fees for the times relevant<sup>1</sup> to the Plan of Adjustment will still be subjected to it. Therefore, Cabarets are not seeking to violate the Plan of Adjustment in any manner, and Detroit’s Motion should be denied.

The liquidated amount of Cabarets’ claim for attorney fees and costs has been left for determination by the district court, subject to appeals to courts of competent jurisdiction. At no point before or after the district court magistrate issued – after the bankruptcy stay – its report and recommendation on the request for attorney fees, did the City argue that it was improper for the Cabarets to be proceeding before the district court to determine the liquidated amount.

<sup>1</sup> Cabarets have also incurred attorney fees and costs on their first successful appeal to the Sixth Circuit, which occurred after the City “emerged from bankruptcy” in 2014.

Now for the first time after years of litigation in the district court, and the filing of Cabarets' principle brief in the Appeal, the City essentially argues that the Plan of Adjustment limits the arguments Cabarets may raise to determine liquidated amount of their request for attorney fees and costs under 42 U.S.C. § 1988. The City cites no authority for this proposition.

Cabarets' argument to the district court and the Sixth Circuit involves the valuation of claims under the attorney fee provisions of the Civil Rights Act, being 42 U.S.C. § 1988. That statutory provision provides that in an action to enforce certain federal civil rights provisions, the court may award the prevailing party a reasonable attorney's fee as part of the costs to be borne by the losing party.

The lodestar method--which multiplies the reasonable number of hours spent working on a case by the reasonable hourly billing rate--is generally used to calculate attorney fees under § 1988. Pennsylvania v. Delaware Valley Citizens' Council for Clean Air, 478 U.S. 546, 565, 106 S. Ct. 3088, 3098, 92 L. Ed. 2d 439 (1986) ("Delaware Valley I"), supplemented, 483 U.S. 711, 107 S. Ct. 3078, 97 L. Ed. 2d 585 (1987) ("Delaware Valley II").

In Perdue v. Kenny A. ex rel Winn, the Supreme Court held that a reasonable fee for the purposes of 42 U.S.C. § 1988 is one that "is sufficient to induce a capable attorney to undertake the representation of a meritorious civil rights case." 559 U.S. 542, 552 (2010). This Court has similarly held that the statute should be construed

liberally in order to effectuate its purpose. Seals v. Quarterly County Court of Madison County, Tennessee, 562 F.2d 390, 393 (6th Cir. 1977).

In Perdue, the Supreme Court recognized that the “rare and exceptional circumstances” supporting a fee enhancement may include “exceptional delay in the payment of fees,” especially “where the delay is unjustifiably caused by the defense.” 559 U.S. at 556. This comports with the 42 U.S.C. § 1988’s basic purpose of encouraging attorneys to take on civil rights cases on a contingent basis. Id. (stating that “an enhancement may be appropriate where an attorney assumes these costs in the face of unanticipated delay”). The Court reasoned that defendants are less likely to settle when there is uncertainty regarding the amount of fees that will eventually be awarded by a judge with unlimited fee enhancement discretion. Id. at 558-59. Fee enhancements are also designed for circumstances where “the lodestar does not adequately take into a factor that may properly be considered in determining a reasonable fee.” 559 U.S. at 554.

Cabarets’ argument in the Appeal that Detroit’s municipal bankruptcy constitutes “delay” or “other circumstances” where the lodestar amount may permissibly be adjusted does not in any way ask for an order collaterally attacking any order of this Court.

By way of example, the currently grand total awarded by the District Court is approximately \$905,718.65. [Motion, p. 3]. As the City has pointed out [Id. at 7],

Cabarets each originally filed a claim in the amount of \$1,563,107.76. If, for example, the Sixth Circuit determines that the present circumstances merit a fee enhancement under Perdue, and the district court subsequently applied a fee enhancement of 50%, the resulting amount of approximately \$1,358,577.98 would still be less than the amount of claim filed by each of the Cabarets.

Certainly, Cabarets have requested a much greater enhancement, which would eclipse the claims originally submitted. However, whether the final amount of the award, the liquidated amount, is limited by the original claim is a subject to be addressed when it is actually presented to the Court.

The issue of whether a municipal bankruptcy, either here or under any circumstances, can support an upward departure from the lodestar figure in a 42 U.S.C. § 1988 request for fees and costs is an issue that should be resolved in the Appeal. The Appeal does not violate any of the injunctive provisions of the Plan cited by the City in its Motion. [Doc. 12852, p. 6]. It is simply part of the process to determine the precise liquidated value of the Cabarets' claims.

Because the subject matter of the Appeal is to determine the liquidated amount subject to the Plan of Adjustment and involves an important and unique question under 42 U.S.C. § 1988 jurisprudence, Cabarets should not be enjoined from maintaining the appeal.

## II. THE CITY'S CLAIM FOR ATTORNEY FEES AND COSTS SHOULD BE DENIED.

The City has articulated no permissible basis for its request for attorney fees and costs. In addition, the City incurred the attorney fees it now seeks while failing to contend that the litigation in the district court was contrary to the Plan.

Generally “the ‘basic point of reference when considering the award of attorney’s fees is the bedrock principle known as the American Rule: Each litigant pays his own attorney’s fees, win or lose, unless a statute or contract provides otherwise.’” Baker Botts L.L.P. v. ASARCO LLC, — U.S. —, 135 S.Ct. 2158, 2164, 192 L.Ed.2d 208 (2015) (quoting Hardt v. Reliance Standard Life Ins. Co., 560 U.S. 242, 252–53, 130 S.Ct. 2149, 176 L.Ed.2d 998 (2010)). In re Formosa, 582 B.R. 423, 429 (Bankr. E.D. Mich. 2018) (quoting Baker Botts L.L.P. v. ASARCO LLC, — U.S. —, 135 S.Ct. 2158, 2164, 192 L.Ed.2d 208 (2015) (quoting Hardt v. Reliance Standard Life Ins. Co., 560 U.S. 242, 252–53, 130 S.Ct. 2149, 176 L.Ed.2d 998 (2010))). The City has identified no statute or Plan provision which provides for the attorney fees it seeks. Respectfully, awarding the City its attorney fees for the Appeal was an error of law that should be corrected upon reconsideration.

In addition, the district court resumed the underlying suit in May of 2016. The Cabarets submitted their second request for attorney fees on September 20 of 2016. [Ex. 6-1, Entry No. 174].



### **III. RECONSIDERATION SHOULD BE GRANTED**

Rule 9024-1(a)(3) provides that:

Generally, and without restricting the discretion of the court, a motion for reconsideration that merely presents the same issues ruled upon by the court, either expressly or by reasonable implication, will not be granted. The movant must not only demonstrate a palpable defect by which the court and the parties have been misled but also show that a different disposition of the case must result from a correction thereof.

The present motion does not request litigation of any issues previously presented by the Court. Rather, the motion presents the issues in full to the Court for the first time. The Cabarets' response to the City's motion was not timely presented to the Court due to its counsels' inability to file the response electronically and unfamiliarity with the proper means of seeking leave to file the response in paper format, as explained above. Counsel prepared to timely file the brief and when electronic filing proved not to be possible, the City denied the Cabarets' request for an extension.

Under the present circumstances, the Cabarets respectfully request that the Court exercise its discretion and reconsider its Order. In addition, respectfully the Order suffers from the palpable defects identified in Sections II and III above, which were not previously presented to the Court.

## **CONCLUSION**

WHEREFORE, for the forgoing reasons, the Cabarets respectfully request that this Honorable Court GRANT the present motion for reconsideration and, upon reconsideration, DENY in full the City's Motion.

**DECLARATION OF MATTHEW J. HOFFER, ESQ.**

NOW COMES Matthew J. Hoffer, and pursuant to 28 U.S.C. § 1746, hereby declares and states the following.

1. I am an attorney licensed to practice law in the State of Michigan and admitted to practice before the United States District Court for the Eastern District of Michigan. I am an employee of Shafer & Associates, P.C. Bradley J. Shafer is an attorney licensed to practice in the State of Michigan and admitted to practice before the United States District Court for the Eastern District of Michigan. Mr. Shafer is the principle of Shafer & Associates, P.C.

2. I make this declaration upon personal knowledge, unless specifically stated to the contrary. I will refer to myself in the third person for the convenience of the reader.

3. Mr. Shafer and Mr. Hoffer are counsel for H.D.V. - Greektown, LLC, 415 East Congress, LLC, and K&P, Inc. (the “Cabarets”) in the above matter; in H.D.V. – Greektown, LLC *et al* v. City of Detroit, United States District Court for

the Eastern District of Michigan Case No. 2:06-cv-11282; and in H.D.V. – Greektown, LLC, et al. v. City of Detroit, United States Court of Appeals for the Sixth Circuit Case No. 18-1203.

4. Mr. Shafer and Mr. Hoffer each took pre-planned vacations during the week of January 2, 2018, Mr. Shafer from July 2 to July 8 and Mr. Hoffer from July 4 to July 8.

5. Mr. Shafer and Mr. Hoffer each attended and presented at the First Amendment Lawyers Association's ("FALA") semi-annual meeting from July 11 to July 14, 2018 in Denver, Colorado, and remained in Denver thereafter to meet with local clients. Mr. Shafer returned on July 16, 2017 and Mr. Hoffer returned on July 17, 2018.

6. Mr. Shafer then spent the week of July 23 in San Diego, California, traveling to, preparing for, attending, and traveling from mediation on a class action matter.

7. The City of Detroit's Motion for the Entry of an Order Enforcing the Plan of Adjustment Injunction Against H.D.V. Greektown, LLC, 415 East Congress, LLC, and K&P, Incorporated [Doc. 12852] (the "Motion"), was filed on July 11, 2013 and received by Shafer & Associates on July 13, 2013. Mr. Hoffer calculated the due date to be July 30, 2018.

8. Upon returning from FALA, Mr. Hoffer's efforts were concentrated on completing an appellate opening brief in Ontario Food & Beverage, LLC, v. Baker (now Schoorl), United States Court of Appeals for the Ninth Circuit Case No. 18-55884, which was ultimately filed on July 31, 2018.

9. Nevertheless, also upon Mr. Hoffer's return from FALA, he tasked a law clerk with research regarding the Motion, including whether any special admission was required to practice before The United States Bankruptcy Court for the Eastern District of Michigan. The research confirmed that no special admission was required. Mr. Hoffer also verified that Shafer & Associate's records contained an ECF/CM login and password for Mr. Shafer for The United States Bankruptcy Court for the Eastern District of Michigan.

10. Mr. Hoffer prepared a response in opposition to the City's Motion for Mr. Shafer's review, and for filing. Upon Mr. Hoffer logging in to file the Motion on July 30, 2018, he learned that Mr. Shafer's login was not valid. Mr. Hoffer then contacted counsel for the City to request an extension to permit the e-filing issue to be corrected. The City of Detroit denied the requested extension.

11. Unable to electronically file a request for an extension, Mr. Hoffer changed the signature block to his own information, physically signed and overnighted the response to the Court via UPS overnight delivery.



12. The attempted physical filing of the response was rejected for filing by the Clerk of the Court for, *inter alia*, failure to contain an ex parte motion for leave to file in the traditional manner and returned to Shafer and Associates. Mr. Hoffer then prepared an ex parte application to file in the traditional fashion, which was resubmitted with the original response, as returned by the Clerk of the Court, which was overnighted to the Court Via UPS on August 7, 2018. That filing was rejected for failing to include a proposed order for the ex parte application.

13. On August 9, 2018, Shafer & Associates received a copy of the Court Order [Doc. 12863] granting the Motion. Mr. Hoffer, then determining under Rule 9024—(a)(1) that a motion for reconsideration was due within 14 days, began the process to obtain training and become a registered e-filer with the Court. The ECF registration process was ultimately complete on August 13, 2018, when Mr. Hoffer received his CM/ECF login and password.

14. Except possibly assisting with the filing of the proofs of claim in the above matter, the Cabaret's response to the City's motion was Mr. Hoffer's first attempt at electronically filing with the Court. The first attempt occurred under pressure of numerous ongoing obligations and while 'catching up' on matters arising while he had been out of the office for two weeks.

**NOTICE OF SUGGESTION OF PENDENCY OF BANKRUPTCY  
CASE AND APPLICATION OF THE AUTOMATIC STAY**

On July 18, 2013 ("the Petition Date"), the City of Detroit, Michigan ("the City") filed a petition for relief under chapter 9 of title 11 of the United States Code ("the Bankruptcy Code"). The City's bankruptcy case is captioned *In re City of Detroit, Michigan*, Case No. 13-53846, (Bankr. E.D. Mich.) ("the Chapter 9 Case"), and is pending in the United States Bankruptcy Court for the Eastern District of Michigan ("the Bankruptcy Court").

In accordance with sections 362 and 922 of the Bankruptcy Code, except as provided for in subsection (b) of section 362, the filing of the Chapter 9 Case operates as a stay, applicable to all entities, of:

(1) the commencement or continuation of any judicial, administrative, or other action or proceeding against the debtor that was or could have been commenced before the filing of the Chapter 9 Case, or to recover a claim against the City that arose before the commencement of the Chapter 9 Case;

(2) the enforcement, against the City or against property of the City, of a judgment obtained before the filing of the Chapter 9 case;

(3) any act to obtain possession of property of the City or to exercise control over property of the City;

(4) any act to create, perfect or enforce any lien against property of the City;

(5) any act to create, perfect or enforce against property of the City any lien, to the extent that such lien secures a claim that arose before the commencement of the Chapter 9 Case;

(6) any act to collect, assess, or recover a claim against the City that arose before the commencement of the Chapter 9 Case; and

(7) the setoff of any debt owing to the City that arose prior to the commencement of the Chapter 9 Case against any claim against the City.

Accordingly, none of the above actions may be commenced or continued against the City without the Bankruptcy Court first issuing an order lifting or modifying the Stay for such specific purpose.

In light of the foregoing, the City will not defend against, or take any other action with respect to, the present case while the Stay remains in effect.

The City hereby expressly reserves all rights with respect to the present case, including, but not limited to, the right to move to vacate any judgment or order entered in the present case while the Stay is in effect as void.

**ORDER ADOPTING REPORT AND RECOMMENDATION [162],  
OVERRULING PLAINTIFFS' OBJECTION [164], AND GRANTING IN  
PART PLAINTIFFS' MOTION FOR ATTORNEY FEES AND COSTS [148]**

Before the Court is a Report and Recommendation ("R&R") [162] entered on May 23, 2013, recommending granting in part Plaintiffs' Motion for Attorney Fees and Costs [148], and awarding \$385,401.12 in fees and costs to Plaintiff counsel for prevailing in the underlying action. Plaintiffs timely filed an Objection [164] and Defendants filed a Response [167]. On August 23, 2013 the Court stayed the Motion for Attorney Fees and Costs [148] because the municipal Defendant had filed for Chapter 9 bankruptcy on July 18, 2013. In December, 2014, the municipal Defendant emerged from bankruptcy; accordingly, the Court will now issue its ruling on Plaintiffs' Motion for Attorney Fees and Costs [148]. For the reasons that follow, Plaintiffs' Motion for Attorney Fees and Costs [148] is GRANTED and Plaintiff counsel is awarded \$372,118.19 in fees and \$13,282.93 in costs.

## BACKGROUND

Plaintiffs obtained a \$2,950,000 settlement in this § 1983 action. Plaintiffs are closely held Michigan limited liability companies in the adult entertainment business. They alleged that Defendants violated mainly their First Amendment rights by hindering the operation of their business with regulations. The parties stipulated that the Court would decide the issue of attorney fees pursuant to 42 U.S.C. § 1988 and that Plaintiffs were the prevailing parties for the purpose of determining fees and costs.

## STANDARD OF REVIEW

This Court reviews *de novo* the portions of the R&R [162] to which objections have been filed. 28 U.S.C. § 636(b)(1); FRCP 72(b). The Court “may accept, reject, or modify, in whole or in part, the findings or recommendations made by the magistrate judge.” *Id.*

## ANALYSIS

Plaintiff counsel seeks \$1,532,640.61 in fees and costs. Defendants concede that Plaintiff counsel is entitled to some fees, but argue that the amount the R&R [162] recommends—\$385,401.12—is reasonable.

“The primary concern in an attorney fee case is that the fee awarded be reasonable,” one that is adequate to attract competent counsel, but does not yield a windfall for lawyers. *Reed v. Rhodes*, 179 F.3d 453, 471 (6th Cir. 1999). The Court



begins by determining the fee applicant's lodestar, which is the proven number of hours *reasonably* expended on the case by an attorney, multiplied by her court-ascertained reasonable hourly rate. *Hensley v. Eckerhart*, 461 U.S. 424, 433 (1983) (emphasis added).

The R&R [162] calculates the lodestar using the hourly rates proposed by Plaintiff counsel themselves. The hourly rates were \$350, \$250, and \$200 for Attorneys Shafer, Pritzlaff, and Hoffer respectively. The R&R [162] concludes, however, that the total number of hours Plaintiff counsel claims to have expended is not reasonable. The reasons the R&R [162] found the number of hours to be unreasonable is two-fold. First, the Magistrate concluded that certain hours are not compensable here. Second, the remaining time spent on the case was excessive. Ultimately, the R&R [162] recommends a total fee-and-costs award of \$385,401.12. The Court agrees that \$385,401.12 is a reasonable award in this case.

### **Objection One: Sixty Percent Reduction in Fees**

Plaintiffs object to the R&R's recommendation that the Court reduce the lodestar by sixty percent. The Magistrate's approach of making a flat percentage cut to attorney fees was well within methods accepted by United States Courts to avoid turning attorney-fee requests into a "second major litigation." *Hensley v. Eckerhart*, 461 U.S. 424, 438 (1983).

Plaintiffs' time sheets for fees are 113 pages long. Plaintiff counsel requests fees for things like communicating with the media, participating in administrative proceedings, watching the evening news, and for work related to the Jane Roe Plaintiffs who were voluntarily dismissed and received no legal relief from this action. Plaintiff counsel requests \$56,795 for preparation of its own fee Motion [148] and \$21,980 for preparation of the Reply [155] alone.

"The purpose of § 1988 is to ensure 'effective access to the judicial process for persons with civil rights grievances.'" HR REP. NO. 94-1558, p. 1 (1976). That fundamental purpose of § 1988 is hardly relevant, let alone compelling here. Plaintiffs are closely held, extraordinarily profitable companies whose access to the judicial and political processes is far greater than most citizens, as demonstrated by the very background of this case. Further removing this Motion [148] from the congressionally intended purpose of § 1988, is the nature of Plaintiffs' grievance in this case—they pursued the least constitutionally important type of First Amendment right. *Kiser v. Reitz*, 765 F.3d 601, 607 (6th Cir. 2014) (holding that advertisements and other commercial speech enjoy less rigorous First Amendment protection than other forms of expression).

Plaintiffs spared no expense protecting their right to utilize the First Amendment to seek pecuniary gain. "While parties to a litigation may fashion it according to their purse and indulge themselves and their attorneys . . . they may not

foist these extravagances upon their unsuccessful adversaries.” *King World Productions, Inc. v. Financial News Network, Inc.*, 674 F. Supp. 438, 440 (S.D.N.Y. 1987). The Court is not required to engage in a line by line analysis of Plaintiff counsel’s 113 pages of fee requests. In light of the indiscriminate approach counsel took to its fee petition and the tangential relationship compelling civil rights have to this case, the Court finds the R&R’s [162] sixty percent reduction recommendation in the lodestar is warranted. This yields a preliminary award of \$361,279.80 before accounting for Plaintiffs’ fee request for preparing its own Fee Motion [148].

### **Objection Two: Sixty Percent Reduction in Costs**

Plaintiffs object to the R&R’s recommendation that their allowable<sup>1</sup> claimed costs—totaling \$33,207.34—should be reduced by sixty percent. Plaintiffs assert that the R&R double dips its reduction because Defendants requested a 50% reduction in attorney hour travel time and the R&R recommends a 60% reduction in travel costs. The award amounts recommended in the R&R [162] reveal that Plaintiffs’ double-dip argument is incorrect. Rather, the Magistrate simply did not grant Defendants’ piecemeal reduction request and implemented an across-the-board reduction without multiplying the reductions. The R&R [162] recommends a cost award of \$13,282.93, which is a 60% reduction from Plaintiffs’ allowable requested costs (\$33,207.34).

<sup>1</sup> Plaintiffs apparently concede in their Objection [164] that the \$164,921.49 in expert witness fees they attempted to recover in their Motion [148] are not allowable as a matter of law in an action under § 1983.

Plaintiffs also argue that the Magistrate cannot recommend reducing costs because they were actually incurred. As the R&R [162] states, it is the reasonableness of costs that is at issue. Just as the attorneys may have expended all of the hours claimed, it was not reasonable to expend so many hours in this case. Similarly, although the claimed costs may have actually been incurred, it was not reasonable to incur them. There is no reason, therefore, that the reduction for the unreasonable attorney fees should not be commensurate with the reduction for the unreasonable costs. A sixty percent reduction is warranted and Plaintiffs are awarded costs in the amount of \$13,282.93.

### **Objection Three: The Jane Roe Plaintiffs**

Plaintiffs object to the R&R's recommendation that they are not entitled to an award of fees for their work on behalf of the Jane Roe Plaintiffs in this action. Plaintiff counsel argues this is true because the Jane Roe Plaintiffs were voluntarily dismissed after the Court entered the consent decree stipulating that Plaintiffs are the prevailing party in this action. That claim is patently false. The Consent Decree [145] was entered on August 23, 2011. The Jane Roe Plaintiffs were dismissed by Stipulation [144] twelve days earlier on August 9, 2011. The dismissal of the Jane Roes—the anonymous Plaintiffs whose speech undergirded the named Plaintiffs' First Amendment claims—before the Consent Decree [145] ensured that they received no relief from the \$2,950,000 award “by issuance of a check made payable to ‘H.D.V.-

Greektown, LLC, 415 East Congress, LLC, K&P, Inc., and Shafer and Associates, P.C., their attorneys.”

#### **Objection Four: Ancillary Proceedings**

##### ***The 2003 Initial Action***

Plaintiffs object to the R&R’s recommendation that they are not entitled to an award of fees for their work related to *H.D.V.-Greektown, L.L.C., et al, v. City of Detroit*, No. 03-74887. The Order [14] dismissing the 2003 action by stipulation states “all claims in this action are dismissed without prejudice and without costs or an award of attorneys fees to any party.” As explained at length in the R&R [162], the placement of the phrase “without prejudice” in that sentence indicates that the substantive claims were dismissed without prejudice, but any claims for costs or fees were dismissed with prejudice. Plaintiffs are not entitled to collect fees or costs related to the 2003 action.

##### ***The Board of Zoning Appeals Proceedings***

The R&R concluded that Plaintiffs are not entitled for their work before the Board of Zoning Appeals (“BZA”) because that work related to the claims in the 2003 action exclusively and, therefore, the fees are excluded for the same reason elaborated in the previous paragraph. Plaintiffs assert, without supporting, that their work at the BZA proceedings in 2004 gave rise to the bulk of their damage claims for lost business in this case in 2006. The work on the BZA proceedings was mostly

defending tickets issued to Plaintiffs for violations of Condition 18, which was the subject of the 2003 action. Consequently, the Court will not award fees for hours spent on the BZA proceedings.

### ***The Conyers/Riddle Criminal Proceedings***

Plaintiffs object to the R&R's recommendation that they are not entitled to an award of fees for their work related to the Monica Conyers and Sam Riddle criminal proceedings. During the government's investigation, Plaintiffs' client Joe Hall received a grand jury subpoena. Plaintiffs now seek fees for their work in relation to preparing for Hall's appearance before the grand jury. Although Plaintiffs argue that that criminal case was the sole basis for the submission of their Second Amended Complaint [84], the fact remains that the guilt or innocence of Conyers or Riddle in the criminal case did not dictate the result in this case. Plaintiffs object that the criminal proceedings had *res judicata* and collateral estoppel consequences to their claims in this action. That claim is unpersuasive as Plaintiffs could never be equitably barred from bringing claims as a result of a criminal action prosecuted by the federal government.

### **Objection Five: Fee Enhancement**

Plaintiffs object to the R&R's recommendation that they are not entitled to a ten percent fee enhancement under *Perdue v. Kenny A. ex rel. Winn*, 559 U.S. 542 (2010). A *Perdue* enhancement is impermissible except in "rare and exceptional

circumstances” and the party seeking the enhancement bears the burden of proving the enhancement is warranted with specific evidence that the lodestar fee would not have been adequate to attract competent counsel. *Id.* at 554. Plaintiff counsel has failed to prove that the lodestar would be inadequate to attract competent counsel for a First Amendment case, given that the lodestar was calculated with a rate that falls above the 75<sup>th</sup> percentile of fees charged by civil rights lawyers.

### **Objection Six: Fees Related to the Attorney Fee Motion**

Plaintiffs object to the R&R’s recommendation that their claimed fees for bringing their Motion for Fees and Costs [148] are excessive. In cases that result in settlement, the hours expended to prepare a fee petition should not exceed three percent of the total award for attorney hours in the underlying case. *Coulter v. State of Tennessee*, 805 F.2d 146, 151 (6th Cir. 1986). Since the Court has awarded \$361,279.80 in attorney fees, an additional \$10,838.39—three percent of the underlying award—is what is allowable for preparation of the fee petition.

For the foregoing reasons, the Court **HEREBY ADOPTS** the R&R [162]. Accordingly,

**IT IS ORDERED** Plaintiffs’ Motion for Attorney Fees and Costs [148] is **GRANTED IN PART**.

**IT IS FURTHER ORDERED** that Plaintiff Counsel is awarded \$372,118.19 in attorney fees.

**IT IS FURTHER ORDERED** that Plaintiff Counsel is awarded \$13,282.93  
in costs.

**IT IS FURTHER ORDERED** that Plaintiffs' Objection [164] is  
**OVERRULED.**
