The above-captioned debtors (collectively, the “Debtors”), in support of their *ex parte* motion for order shortening notice period and scheduling an expedited hearing (the “*Ex Parte* Motion”) on the Debtors’ Motion for the Entry of an Order Approving Asset Purchase

Agreement for the Sale of Assets at Debtors' Evert, Michigan, Belvidere, Illinois and St. Louis, Missouri Facilities Free and Clear of Liens, Claims, Encumbrances and Other Interests and Related Relief (the "Sale Motion"),² respectfully state as follows:

Jurisdiction

1. This Court has jurisdiction over this matter pursuant to 28 U.S.C. § 1334. This matter is a core proceeding within the meaning of 28 U.S.C. § 157(b)(2).
2. Venue is proper pursuant to 28 U.S.C. §§ 1408 and 1409.
3. The statutory bases for the relief requested herein are Rules 9006 and 9007 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules") and Rule 9006-1(b) of the Local Rules of the United States Bankruptcy Court, Eastern District of Michigan (the "Local Rules").

Background

4. On May 17, 2005 (the "Petition Date"), the Debtors filed their voluntary petitions for relief under chapter 11 of the Bankruptcy Code. The Debtors are operating their businesses and managing their properties as debtors in possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code. On the Petition Date, the Court entered an order jointly administering these cases pursuant to Bankruptcy Rule 1015(b).
5. On May 24, 2005, the United States trustee appointed the official committee of unsecured creditors pursuant to section 1102 of the Bankruptcy Code (the "Committee").
6. On January 11, 2007, the Court approved on a final basis that certain Customer Agreement (the "Customer Agreement") by and between the Debtors, the agents for the Debtors' senior, secured prepetition and postpetition lenders (the "Agents") and certain of the

Debtors' principal customers (the "Customers") [Docket No. 3890]. The Customer Agreement, among other things, provides for a framework to facilitate the orderly sale of a majority of the Debtors' businesses with the support of the Agents and the Customers.

7. On January 24, 2007, the Debtors filed the First Amended Joint Plan of Collins & Aikman Corporation and Its Debtor Subsidiaries [Docket No. 3976] (as modified, the "Plan"). On January 26, 2007, the Court entered an order approving the Debtors' amended disclosure statement related to the Plan [Docket No. 3988]. The Plan is supported by the unofficial steering committee for the Debtors' senior, secured prepetition lenders, the Committee and the Customers. This Court has scheduled a hearing on confirmation of the Plan for July 12, 2007.

8. The Debtors, in consultation with the agent for the Debtors' prepetition senior, secured lenders (the "Prepetition Agent"), determined that the sale of the business (the "Business") at the Debtors' Evert, Michigan, Belvidere, Illinois and St. Louis, Missouri facilities (collectively, the "Facilities") as a going concern would maximize value for the Debtors' estates and creditors. After an extensive marketing process and examining the bids received from potential buyers, the Debtors and their advisors, in consultation with the Prepetition Agent, determined that the offer from Ventra Evert, LLC, Ventra Belvidere, LLC, Ventra St. Louis, LLC and Ventra Assembly Company (collectively, the "Purchaser") was the highest and best offer received by the Debtors. As a result of extensive, arm's-length negotiations, on June 11, 2007, the Debtors (with the support of the Prepetition Agent) and the Purchaser executed an asset purchase agreement regarding the sale of assets related to the Business (the "Asset Purchase Agreement").

9. Contemporaneously with the filing of this *Ex Parte* Motion, the Debtors filed the Sale Motion, seeking Court approval of the Asset Purchase Agreement and other related relief.

Relief Requested

10. The Debtors request that, pursuant to Bankruptcy Rule 9006(c) and Local Rule 9006-1(b), the Court shorten the notice period for objecting or otherwise responding to the Sale Motion to June 19, 2007 at 4:00 p.m. prevailing Eastern Time and schedule the Sale Motion to be heard at the omnibus hearing scheduled for June 21, 2007 at 2:00 p.m. prevailing Eastern Time or as soon thereafter as counsel may be heard.

Basis for Relief

11. Pursuant to Bankruptcy Rule 9007, the Court has authority to regulate the time within which, the entities to whom and the form and matter in which, notice shall be given, which includes the authority to determine appropriate notice for conducting a hearing on the matters presented by the Sale Motion.

12. The Debtors and the Purchaser believe that time is of the essence in the closing of the transaction. In particular, to maximize the value of the assets and preserve the viability of the Business, the Asset Purchase Agreement provides for a closing date no later than June 30, 2007. As set forth in the Sale Motion, the Asset Purchase Agreement is (a) the highest and best offer received, (b) the only offer capable of satisfying current and future contracts with DaimlerChrysler Company, LLC, f/k/a DaimlerChrysler Corporation — the Facilities' largest customer — and (c) the only offer capable of maintaining the Business as a going concern and preserving a significant amount of jobs.

13. Accordingly, for the reasons set forth above and in the Sale Motion, good and sufficient cause exists to consider the Sale Motion on an expedited basis as set forth herein.

WHEREFORE, the Debtors respectfully request the entry of an order, substantially in the form attached hereto as **Exhibit A**, (a) shortening the period for objecting or otherwise responding to the Sale Motion to June 19, 2007 at 4:00 p.m. prevailing Eastern Time, (b) scheduling an expedited hearing on the Sale Motion on June 21, 2007 at 2:00 p.m. prevailing Eastern Time or as soon thereafter as counsel may be heard and (c) granting such other and further relief as this Court deems appropriate.

and St. Louis, Missouri Facilities Free and Clear of Liens, Claims, Encumbrances and Other Interests and Related Relief [Docket No. 7447] (the “Sale Motion”);² it appearing that the Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334; it appearing that this proceeding is a core proceeding pursuant to 28 U.S.C. § 157(b)(2); it appearing that venue of this proceeding and the *Ex Parte* Motion in this District is proper pursuant to 28 U.S.C. §§ 1408 and 1409; it appearing that notice of the *Ex Parte* Motion and the opportunity for a hearing on the *Ex Parte* Motion was appropriate under the particular circumstances and that no other or further notice need be given; and after due deliberation and sufficient cause appearing therefor, it is hereby ORDERED

1. The *Ex Parte* Motion is granted in its entirety.

2. A hearing on the Sale Motion will be conducted before the Honorable Steven W. Rhodes on June 21, 2007 at 2:00 p.m. prevailing Eastern Time or as soon thereafter as counsel may be heard in the United States Bankruptcy Court, 211 W. Fort Street, Detroit, Michigan 48226.

3. The objection deadline for the relief requested by the Debtors in the Sale Motion shall be June 19, 2007 at 4:00 p.m. prevailing Eastern Time.

4. The Debtors shall immediately serve a copy of this Order and, to the extent such motion has not previously been served, the Sale Motion upon the Core Group and the 2002 List.³
