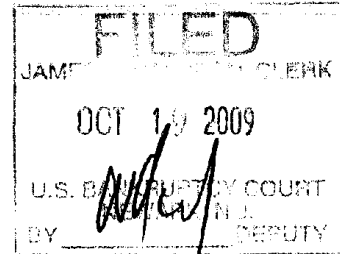

This matter having been raised to this Court by the application (the "Application") of Allen D. Wilen, in his capacity as Liquidating Trustee and Estate Representative (the "Liquidating Trustee") for the bankruptcy estate of the captioned debtor, Bayonne Medical Center (the "Debtor"), for an Order pursuant to Rule 9006(c)(1) of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules") shortening time for notice of the hearing (the "Hearing") on the Liquidating Trustee's motion (the "Motion") for the entry of an Order authorizing the Liquidating Trustee to file omnibus objections to claims in amounts inconsistent with the Debtor's books and records; and this Court having considered the Application, its supporting materials, and all responses thereto, if any; and after due deliberation thereon; and good and sufficient cause appearing therefor, it is hereby:

ORDERED, that the time period required by LBR 9013-1(c) for notice of the Hearing is shortened as set forth herein; and it is further

ORDERED, that the Hearing shall be conducted on Nov. 2, 2009, at 10 A.m., before the Honorable Morris Stern, U.S.B.J., on the third floor of the Martin Luther King Building and U.S. Courthouse, 50 Walnut Street, Newark, New Jersey 07101; and it is further

ORDERED, that true copies of this Order, the Application seeking the entry of this Order, and the Motion papers shall be served upon (i) the United States Trustee for Region 3, Newark, New Jersey; (ii) counsel for the Debtor; (iii) any claimants whose claims may be the subject of an omnibus objection based on discrepancies between their respective claims and the Debtor's books and records; and (iv) all parties requesting notice pursuant to Fed. R. Bankr. P.
