WHEREAS, on September 15, 2009, Allen D. Wilen, as Liquidating Trustee and Estate Representative for the captioned debtor (the “Trustee”) filed with the Court an eleventh omnibus objection to certain claims, pursuant to 11 U.S.C. § 502 and *Fed.R.Bankr.P.* 3007 (the “Omnibus Objection”); and

WHEREAS, the Court sustained the Omnibus Objection by order dated October 20, 2009 (the “Order”); and

WHEREAS, on or about November 13, 2009, Brian Newsome, through his undersigned counsel, filed a motion for reconsideration of the Order (the “Motion”) to the extent that it expunged Mr. Newsome’s claim (the “Newsome Claim”); and

WHEREAS, Mr. Newsome and the Trustee have agreed to resolve the Motion by allowance of the Newsome Claim for the sole and limited purpose of enabling Mr. Newsome to maintain worker’s compensation claims payable to or on behalf of Mr. Newsome by parties other than the Debtor, and not for the purpose of obtaining any monetary distribution from the Debtor’s estate; and

IT IS hereby stipulated and agreed by the parties hereto, through their authorized counsel, as follows:

1. The Order is hereby modified to overrule the Omnibus Objection, in part, to allow the Newsome Claim for the sole and limited purpose of enabling Mr. Newsome to maintain worker’s compensation claims payable to or on behalf of Mr. Newsome by parties other than the Debtor, and not for the purpose of obtaining any monetary distribution from the Debtor’s estate.
