ORDER PURSUANT TO SECTIONS
105(a) AND 363 OF THE BANKRUPTCY CODE AUTHORIZING BUT
NOT DIRECTING (I) WASHINGTON MUTUAL, INC. TO EXERCISE ITS
OWNERSHIP RIGHTS OVER CERTA
IN INSURANCE POLICIES, (II) THE DISTRIBUTION OF THE POLICY
PROCEEDS, AND (III) THE TERMINATION OF A REVOCABLE GRANTOR
TRUST OF WASHINGTON MUTUAL, INC.

Upon the motion, dated April 16, 2009 (the "Motion"), of Washington Mutual, Inc. ("WMI"), as debtor and debtor in possession, for entry of an order, pursuant to sections 105(a) and 363 of title 11 of the United States Code (the "Bankruptcy Code"), authorizing, subject to WMI's sole discretion, (i) WMI to exercise ownership rights (e.g., surrender, ownership change, withdrawal, etc.) over the Policies listed on Exhibit "1" attached hereto (ii) where applicable, PacLife to remit any proceeds of the Policies to the Trustee, (iii) where applicable, the Trustee to distribute any and all Policy

proceeds to WMI, and (iv) the termination of the Trust,³ all as more fully set forth in the Motion; and the Court having jurisdiction to consider the Motion and the relief requested therein pursuant to 28 U.S.C. §§ 157 and 1334; and consideration of the Motion and the relief requested therein being a core proceeding pursuant to 28 U.S.C. § 157(b); and venue being proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409; and due and proper notice of the Motion having been provided to the parties listed therein, and it appearing that no other or further notice need be provided; and the Court having determined that the relief sought in the Motion is in the best interests of WMI, its creditors, and all parties in interest; and the Court having determined that the legal and factual bases set forth in the Motion establish just cause for the relief granted herein; and upon all of the proceedings had before the Court and after due deliberation and sufficient cause appearing therefor, it is

ORDERED that the Motion is granted as set forth herein; and it is further ORDERED that WMI is authorized, but not directed to, exercise any and all of their ownership rights under policies listed on Exhibit "1" annexed hereto (each individually referred to herein as a "Policy" and collectively referred to herein in as "Policies"), including, without limitation, a surrender, sale, transfer, or withdrawal of the Policies; and it is further

³ In addition to the 105 Policies noted above, there are two Policies in the Trust that are, among other things, the subject of an adversary proceeding filed (the "<u>Adversary Proceeding</u>") by JPMorgan Chase against the Debtors (list bills #7675A and #7729A) (the "<u>Disputed Policies</u>"). The Debtors do not seek to enforce any ownership rights over the Disputed Policies nor terminate the Trust at this time.

ORDERED that WMI is authorized to provide PacLife and the Trustee any and all documentation necessary to effectuate the exercise of any of its rights under the Policies; and it is further

ORDERED that, if directed by WMI, PacLife shall surrender the Policies within a commercially reasonable amount of time, terminate such Policies, and in accordance with the terms thereof, transfer any and all amounts constituting the Cash Surrender Value of the Policies to the Trustee; and it is further

ORDERED that, in the event that any Insured passes away prior to the delivery of the Cash Surrender Value to WMI, PacLife shall convey the death benefit under the applicable Policy to the Trust for the benefit of WMI, and WMI shall not be entitled to the Cash Surrender Value of the applicable Policy covering such Insured; and it is further

ORDERED that, in the event that PacLife has surrendered the Cash
Surrender Value to the Trustee with respect to an Insured and the parties subsequently
determine that the Insured deceased prior to the surrender of the relevant Policy, PacLife
shall pay to the Trustee the difference between the Cash Surrender Value and the
applicable death benefit under such Policy in accordance with the terms of the applicable
Policy; and it is further

ORDERED that, upon receipt, the Trustee shall immediately distribute the proceeds to WMI in accordance with the terms and conditions of the Trust Agreement and pursuant to instructions to be provided by WMI; provided, however, that the Trustee may deduct any reasonable fees and reasonable expenses owed to it under the Trust Agreement pursuant to the terms of the Trust Agreement; and it is further

ORDERED that, subject to resolution of the Adversary Proceeding or agreement of WMI and JPMorgan Chase Bank, N.A., WMI is authorized to terminate the Trust in accordance with the terms of the Trust Agreement; and it is further

ORDERED that this Court shall retain jurisdiction to hear and determine all matters arising from or related to the implementation, interpretation and/or enforcement of this Order.
