
PLEASE TAKE NOTICE that, pursuant to the *Order Granting Motion of the Debtors and Debtors-in-Possession for an Administrative Order Pursuant to 11 U.S.C. §§ 105(a) and 331 Establishing Procedures for Interim Compensation and Reimbursement of Expenses of Professionals dated October 30, 2008* [Docket No. 204] and the *Amended Administrative Order Establishing Procedure for Interim Compensation and Reimbursement of Expenses of Professionals dated November 14, 2008* [Docket No. 302] (the “Administrative Order”), Davis Wright Tremaine LLP (“DWT”) hereby files its *Notice of Second Interim Fee Application Request of Davis Wright Tremaine LLP for the Period From February 1, 2009 Through May 31, 2009* (the “Interim Fee Application”) with the United States Bankruptcy Court for the District of Delaware, 824 Market Street, 3<sup>rd</sup> Floor, Wilmington, Delaware 19801 (the “Bankruptcy Court”). PLEASE TAKE FURTHER NOTICE THAT IF NO OBJECTION IS TIMELY FILED AND SERVED WITH RESPECT TO THE INTERIM FEE APPLICATION BY THE OBJECTION DEADLINE, THE BANKRUPTCY COURT MAY ENTER AN ORDER GRANTING TO RELIEF SOUGHT IN THE INTERIM FEE APPLICATION WITHOUT A HEARING.
