ORDERED that nothing contained herein (a) shall be, or shall be deemed to be, a determination that JPMorgan Chase Bank, NA or any of its affiliates or subsidiaries ("JPMC"), Washington Mutual Bank ("WMB") or any of WMB's subsidiaries, or any other person is or is not liable or responsible in any way for any of the claims that are the subject of this Order or (b) shall prejudice (i) any of JPMC's rights or claims against the Debtors to the extent such rights or claims are (A) asserted in proofs of claim timely filed by JPMC against the Debtors, as such claims may be amended or modified pursuant to applicable bankruptcy law, or (B) provided for or permitted to be asserted pursuant to an order of this Court entered, or to be entered, upon notice and a hearing to the extent notice and a hearing is required, or (ii) the rights of the Debtors or any other parties in interest to object thereto.; and it is further

ORDERED that Kurtzman Carson Consultants, LLC, the Debtors' courtappointed claims and noticing agent, is authorized and directed to delete the claims listed on

Exhibit A hereto from the official claims register in these chapter 11 cases; and it is further

ORDERED that this Court shall retain jurisdiction to hear and determine all
